EXPEDITED SETTLEMENT AGREEMENT

The U.S. Environmental Protection Agency ("EPA") alleges that Nagra Inc. ("Respondent"), owner or operator of the Underground Storage Tank(s) (USTs) at 1408 W Sims Way, Port Townsend, Washington (the "UST Facility"), failed to comply with the following requirement(s) of Subtitle I of the Resource Conservation and Recovery Act (RCRA), 42 U.S.C. §§ 6991-6991m, and Chapter 173-360 of the Washington Administrative Code (WAC).

Failure to monitor each underground storage tank at least every 30 days as required by WAC 173-360-335 (2)(a) as follows: Tank #1 from July 2015 to January 2016, March 2016 and May 2016; and Tank #3, for September 2015, and from November to December 2015.

1. The EPA and the Respondent agree that settlement of this matter for a penalty of \$3,400 is in the public interest.
2. The EPA is authorized to enter into this Expedited Settlement Agreement and Final Order (ESA) pursuant to section 9006 of RCRA and 40 C.F.R. § 22.13(b).
3. In signing this ESA, the Respondent: (1) admits that the Respondent is subject to requirements listed above in Paragraph 1, (2) admits that the EPA has jurisdiction over the Respondent and the Respondent's conduct as alleged herein, (3) neither admits nor denies the factual allegations contained herein, (4) consents to the assessment of this penalty, and (5) waives any right to contest the allegations contained herein.
4. By its signature below, the Respondent certifies, subject to civil and criminal penalties for making a false submission to the United States Government, that he or she has: (1) corrected the alleged violations, (2) submitted true and accurate documentation of those corrections, (3) provided a deposit for payment of the civil penalty in Paragraph 2 above in accordance with the EPA penalty collection procedures provided to the Respondent, (4) submitted true and accurate proof of deposit for payment of the civil penalty with this ESA, and (5) agrees to release the deposit for payment to the EPA upon entry of this Order.

5. Upon filing, this ESA shall constitute full settlement of all claims for civil penalties under RCRA for the violation(s) alleged herein.
6. The EPA reserves all of its other rights to take enforcement action for any past, present, or future violations by the Respondent of RCRA, any other federal statute or regulation, or against any violations alleged to have been corrected pursuant to this ESA that were not corrected.
7. Upon signing and returning this ESA to the EPA, the Respondent waives the opportunity for a hearing or appeal pursuant to section 9006(b) of RCRA or 40 C.F.R. part 22.
8. Each party shall bear its own costs and fees, if any.
9. This ESA is binding on the parties signing below, and in accordance with 40 C.F.R. § 22.31(b), is effective upon filing.






