ORDER ON JOINT  
MOTION TO AMEND  
ADMINISTRATIVE COMPLAINT  
AND CONSENT AGREEMENT

On November 3, 2011, the Parties filed a Joint Motion to Amend Administrative Complaint and Consent Agreement. The Motion requests, pursuant to paragraphs D.1.a and F.13 of the Agreement, that the Complaint and Consent Agreement be amended to include a Revised Appendix A and modification of the penalty.

The Revised Appendix A substitutes the original Appendix A by adding one source that was inadvertently omitted, updating information related to two sources and splitting an additional source to three sources due to a reconfiguration of facilities. This amendment increases the number of existing emission sources from 137 to 140 and thereby, increases the penalty to \$420,000 from \$411,000 as contemplated by paragraph E.1 of the original Administrative Complaint and Consent Agreement.

The Parties also request the amended document contain the correct zip code for Notification in Section D.

The court hereby approves the Motion to Amend to include the Revised Appendix A, the modification to paragraph E.1 based on the terms of the Complaint and Consent Agreement and the new zip code in Section D for good cause shown, pursuant to 40 C.F.R. §§22.14(c), 22.16(c) and 22.18(b)(2). The Respondent is hereby **ORDERED** to comply with all of the terms of the Consent Agreement, which was effective on August 29, 2011 by Final Order.
