Pursuant to 40 C.F.R. §§ 22.16(a) and 22.18(a), Complainant, United States Environmental Protection Agency, Region 8 (EPA), and Respondent, Pendragon Energy Partners, Inc. (collectively the Parties), by their undersigned representatives, hereby request an extension of time for Respondent to pay the penalty in full for the reasons set forth below.

- On September 12, 2007, Complainant issued a complaint alleging certain violations of the Safe Drinking Water Act (the Act), 42 U.S.C. §§ 300f to 300j-26. The complaint proposed a civil penalty for the violations alleged therein.
- According the return receipt (tracking number 70012510000632020821), Respondent received the complaint on September 14, 2007.
- Per 40 C.F.R. § 22.15, Respondent is required to file an answer with the Regional Hearing Clerk within 30 days after service of the complaint; specifically, October 19, 2007.
- As required by the Act and 40 C.F.R. part 22, prior to the assessment of a civil penalty, EPA provides public notice of the proposed penalty set forth in a complaint, reasonable opportunity for people to comment on the matter and present evidence in the event a hearing is held. 42 U.S.C. § 300h-2(c)(3)(B) and 40 C.F.R. § 22.45(b).
- On September 24, 2007, and pursuant to 42 U.S.C. § 300h-2(c)(3)(B) and 40 C.F.R. § 22.45(b), EPA provided public notice of the proposed penalty in this matter.
- On September 26, 2007, Complainant's and Respondent's representatives reached a

settlement in principle that resolved the violations alleged in the complaint. Respondent agreed to pay the full penalty proposed in the complaint in accordance with 40 C.F.R. § 22.18(a).

- According to 40 C.F.R. §§ 22.18(a) and 22.45(c)(3), no proceeding subject to the public notice and comment provisions of the Act may be resolved under 40 C.F.R. § 22.18 until 10 days after the close of the comment period.
- The Consolidated Rules of Practice specify that in a proceeding subject to the public comment provisions of 40 C.F.R. § 22.45, a quick resolution is not available until 10 days after the close of the comment period. 40 C.F.R. § 22.18(a)(2). Therefore, the earliest Respondent can pay the penalty in full is November 3, 2007.
- Pursuant to 40 C.F.R. § 22.18(a)(2), Respondent agrees to pay the penalty amount in full as set forth in the complaint in this matter within 60 days of receipt of the complaint. The specific date for payment is between November 3, 2007 and November 13, 2007 to avoid a default pursuant to 40 C.F.R. § 22.17.

Based on this rationale, the Parties request a 60 day extension for Respondent to pay the full penalty amount between November 3, 2007 and November 13, 2007.
