ORDER GRANTING RESPONDENTS' AMENDED REQUEST FOR EXECUTION OF SUBPOENAS

This proceeding arises under the authority of Section 3008(a) of the Solid Waste Disposal Act, as amended, commonly referred to as the Resource Conservation and Recovery Act of 1976, as amended by the Hazardous and Solid Waste Amendments of 1984 (collectively referred to as "RCRA"), 42 U.S.C. § 6928(a). This proceeding is governed by the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits ("Rules of Practice"), 40 C.F.R. §§ 22.1-22.32. The hearing in this matter is scheduled to begin on July 25, 2011, in Chicago, Illinois.

On July 8, 2011, Respondents filed a Request for Execution of Subpoenas ("Request") pursuant to Section 22.21(b) of the Rules of Practice, 40 C.F.R. § 22.21(b). On July 13, 2011, the undersigned received an Amended Request for Execution of Subpoenas ("Amended Request") from Respondents. Respondents seek subpoenas for the appearance and testimony at the hearing of Mr. Gary Westefer, an Illinois Regulatory Specialist at the U.S. Environmental Protection Agency ("EPA" or "USEPA"), Region 5, and Ms. Mary Allen, Recycling and Education Director of the Solid

Waste Agency of Northern Cook County.² To date, Complainant has not filed a response to Respondents' Request or Amended Request.

Pursuant to Section 22.21(b) of the Rules of Practice, the presiding Administrative Law Judge "may require the attendance of witnesses or the production of documentary evidence by subpoena, if authorized under the Act, upon a showing of the grounds and necessity therefor, and the materiality and relevancy of the evidence to be adduced." 40 C.F.R. § 22.21(b). Section 3008(b) of RCRA, 42 U.S.C. § 6928(b), authorizes the issuance of subpoenas for the attendance and testimony of witnesses, as well as for the production of relevant papers, books, and documents, in proceedings arising under the authority of Section 3008 of RCRA.

In their Amended Request, Respondents state that the witnesses for whom Respondents seek subpoenas may be reluctant to testify without the issuance of a subpoena. Respondents represent that Mr. Westefer is expected to testify to "his knowledge of the Illinois Universal Waste Rule, the status of the Illinois Universal Waste Rule and any agreements he may be aware of between the USEPA and Illinois regarding the Illinois Universal Waste Rule." Amended Request. Respondents further represent that the Solid Waste Agency of Northern Cook County, for which Ms. Allen serves as Recycling and Education Director, manages "various types of recycling programs[,] including spent lamps[,] for their member communities." Id. Respondents assert that Ms. Allen is expected to testify as to the condition of Respondents' property as of October 5, 2007, the date on which she visited the property; River Shannon Recycling's general housekeeping practices at the property; and River Shannon Recycling's "methods of managing large quantities of spent lamps . . . generated and staged at its warehouse." Id.

As a condition precedent to granting a request for the issuance of subpoenas, Section 22.21(b) of the Rules of Practice requires a showing of the grounds and necessity therefor, along with the materiality and relevancy of the evidence to be adduced. See Blackinton Common, LLC, and CG2, Inc., EPA Docket No. RCRA-01-2007-0164, 2008 EPA ALJ LEXIS 43, at *7 (ALJ, Nov. 13, 2008). I find that the discussion of Mr. Westefer and Ms. Allen's expected testimony, as set forth in Respondents' Amended Request, sufficiently meets these requirements. Accordingly, Respondents'
