NOTICE OF WITHDRAWAL OF COMPLAINT WITHOUT PREJUDICE

- 1. Complainant, the Division Director, Enforcement and Compliance Assurance Division, United States Environmental Protection Agency, Region IX ("EPA"), provides notice of withdrawal with prejudice of: (1) the Determination of Violation, Compliance Order and Notice of Right to Request a Hearing filed under Docket No. RCRA-09-2009-0017 ("First Complaint"), and (2) the Determination of Violation, Compliance Order and Notice of Right to Request a Hearing filed under Docket No. RCRA-09-2010-0003 ("Second Complaint"), including any amendment(s) to the Second Complaint, in this matter, as follows:
- 2. Pursuant to the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits ("Consolidated Rules of Practice"), 40 C.F.R. § 22.14(d), the complainant may withdraw the complaint, or any part thereof, without prejudice one time before the answer has been filed.
 - 3. On September 3, 2009, Complainant lodged the First Complaint in this matter.
- 4. Complainant served a copy of the First Complaint via certified mail, return receipt requested, and by Federal Express, on Robert Pang, President and Registered Agent of ZKW Trading Corp.
- 5. Robert Pang and EPA agreed to use September 9, 2009, as the effective date of service of the First Complaint for the purposes of enforcing deadlines.
- 6. Respondent failed to file an answer to the First Complaint within thirty (30) days of service.

- 7. In January 2010, Complainant filed a Second Complaint, which sought a penalty for Respondent's failure to comply with the final order that resulted from the First Complaint.
- 8. Complainant served a copy of the Second Complaint by certified mail, return receipt requested, and by Federal Express, on Robert Pang, President and Registered Agent of ZKW Trading Corp. on January 5, 2010.
- 9. Respondent failed to file an answer to the Second Complaint within thirty (30) days of service.
- 10. To date, Respondent has not filed any answer to either the First Complaint or Second Complaint.
- 11. Complainant has not previously filed any withdrawal of the First or Second Complaint, or any part thereof, in this matter.
- 12. Pursuant to Rule 22.14(d) of the Consolidated Rules of Practice, Complainant hereby withdraws the Second Complaint, without prejudice, RCRA 09-2010-0003.
