
On December 14, 2009, the U.S. Environmental Protection Agency (EPA) issued an Administrative Order (Order), ordering the Beaverhead County Jackson Water and Sewer District (Respondent), as owner and/or operator of the Beaverhead County Jackson Water and Sewer District public water system, to comply with certain regulations promulgated under the federal Safe Drinking Water Act, 42 U.S.C. §§ 300f to 300j-26. The Order was updated on April 17, 2013, by the issuance of an Amended Administrative Order (Amended Order).

Among other things, the Order and Amended Order cited violations of the EPA's Consumer Confidence Report (CCR) requirement and directed the Respondent to prepare and distribute annual CCRs and provide certifications as required by 40 C.F.R. §§ 141.152-141.155. (See item 18 on page 4 of the Order and item 21 on page 4 of the Amended Order.)

The EPA's records indicate that the Respondent did not prepare and distribute the annual CCR for 2012 by July 1, 2013, as required by the Order and the Amended Order. Please prepare and distribute the 2012 CCR immediately and provide a copy to the State of Montana and the EPA. Please also note that an additional violation will occur if the Respondent fails to provide the State of Montana and EPA with a certification by October 1, 2013, that the CCR has been distributed as required.

The EPA is considering additional enforcement action as a result of the Respondent's non-compliance with the Order. Violating an administrative order may lead to (1) a penalty of up to \$37,500 per day per violation of the order, and/or (2) a court injunction ordering compliance.
