ORDER TO FILE STATUS REPORT

This action, initiated by the Complainant, the Director of the Compliance Assurance and Enforcement Division, Environmental Protection Agency, Region 6, seeks to assess a Class I administrative penalty under Section 309(g) of the Clean Water Act ("CWA"), 33 U.S.C. § 1319(g). Class I penalty actions are governed by the procedures set forth in 40 C.F.R. Part 22, Subpart I, Administrative Proceedings Not Governed by Section 554 of the Administrative Procedure Act. I have been assigned to act as Presiding Officer in this case.

Complainant filed the Administrative Complaint ("Complaint") in this matter on October 13, 2010. - 1. On or before February 15, 2011, Complainant shall file a report on the status of this matter, including, at a minimum, (1) a statement concerning whether the Complainant has been successful in completing service of the Complaint on Respondent; (2) if Complainant has not been successful in completing service on the Respondent, Complainant's plan for completing service or otherwise bringing this case to conclusion: (3) if Complainant has been successful in completing service on the Respondent, the date and method of service and the nature of the documentation establishing service, a statement concerning Complainant's intention to file a motion for default, and, if applicable, the Complainant expects to file its motion, a summary of recent contacts, if any, between the parties (without disclosing the substance of settlement negotiations, an assessment of whether this matter is likely to be settled, and, if applicable, a projected date for the filing of a consent agreement and final order.
- 2. If Complainant has a return receipt (green card) or other documentation showing that the

Complaint was successfully delivered to the Respondent, Complainant shall file such documentation with the Regional Hearing Clerk on or before <u>February 15, 2011</u>.
