

7. During the May 30, 2008 discussion it was agreed that further discussion of settlement options would likely yield expeditious settlement of this matter.


8. Accordingly, M.F. Reynolds requests that it be granted an extension of time until July 2, 2008 to respond to the notice.

For the above reasons, M.F. Reynolds respectfully requests that it be granted an extension of time until July 2, 2008 to respond to the Notice.


