# APPELLEE'S RESPONSE TO RESPONDENT KLOCKENKEMPER'S MOTION FOR LEAVE TO FILE AMENDED NOTICE OF APPEAL

Pursuant to 40 C.F.R. §§ 22.16(b) and 22.30(e) of the Consolidated Rules of Practice

Governing the Administrative Assessment of Civil Penalties, Issuance of Compliance or

Corrective Action Orders, and the Revocation, Termination or Suspension of Permits,

("Consolidated Rules" or "CROP"), the United States Environmental Protection Agency,

Region 5 ("Appellee/Complainant"), files the instant Appellee's Response to Respondent

Klockenkemper's Motion for Leave to File Amended Notice of Appeal ("Appellee's Response").

On or about October 7, 2008, Appellant/Respondent Klockenkemper filed his motion for leave to file an amended notice of appeal, ("Appellant's/Respondent's Motion" or "the Motion"). Appellee/Complainant initially declined to agree with Appellant's/Respondent's initial request to amend his notice of appeal, but reviewed its position and subsequently determined that it does not object to Appellant's/Respondent's proposed amendment of his notice of appeal, as specifically articulated in Attachment A to his Motion. Appellee/Complainant objects, however, to Appellant's/Respondent's request to file "... an Amended Notice of Appeal similar to that attached hereto (give or take an interlocutory order to two), simultaneously with his Brief, on

or before October 31, 2008, ..." See Appellant's/Respondent's Motion at p. 3. (Emphasis added).

There is no need for Appellant/Respondent to file a notice of appeal that is "... similar to that attached [to his Motion]... (give or take an interlocutory order to two) ...." Appellant/Respondent asked the Environmental Appeals Board ("EAB" or "the Board") on the first page of his Motion (in the first unnumbered paragraph), that he be allowed to file "an Amended Notice of Appeal ..., a proposed copy of which Amended Notice is attached hereto." This suggests that Attachment A is the amended notice of appeal that is at issue for acceptance by the EAB. Additionally, Appellant/Respondent represented to the Board that the "... amendment of his notice of appeal merely seeks to clarify the fact that Ms. Toney was not the only Presiding Officer whose final and applicable interlocutory orders are being appealed, ..." and that his "... proposed amendment is a matter of form rather than substance..." See Appellant/Respondent Klockenkemper's Motion at paragraphs 3 and 4. Having clarified any alleged confusion in the record and corrected alleged problematic matters of form with his Motion and proposed amended notice of appeal (at Attachment A to the Motion), Appellant/Respondent should have no need to provide the Board with yet another version of an amended notice of appeal. Therefore, if the EAB grants Appellant's/Respondent's, the amended notice of appeal that is Attachment A to his Motion should be the one that is filed in this matter.

It is also unclear why Appellant/Respondent seeks to file an amended notice of motion at this late date, given that the EAB has already provided Appellants/Respondents with two extensions of time to file their brief in support of their appeal, which now must be filed on or before October 31, 2008. As noted above, Appellant/Respondent represented to the EAB that

the "...amendment of his notice of appeal *merely seeks to clarify* the fact that Ms. Toney was not the only Presiding Officer whose final and applicable interlocutory orders are being appealed, ..." and that his "... proposed amendment is a *matter of form rather than substance*..." *See* Appellant/Respondent Klockenkemper's Motion at paragraphs 3 and 4. (Emphasis added). Therefore, based on Appellant's/Respondent's representations, there are no new substantive matters in the amended notice of appeal that go beyond what he contemplated in his original notice of appeal that was filed on or about July 28, 2008. Accordingly, Appellants/Respondents should not require any extra time, beyond the twice-extended deadline of October 31, 2008, to craft an appellate brief that addresses all matters for appeal in the initial and amended notices of appeal.

For the reasons set forth above, Appellee/Complainant respectfully requests that, if the EAB grants Appellant's/Respondent's Motion, it issue an order designating Attachment A to the Motion as the amended notice of appeal to be filed with the Board. In addition, Appellee/Complainant respectfully requests that this Board issue an order that clarifies that the twice-extended October 31, 2008 due-date for the Appellants'/Respondents' appeal brief is the final deadline for them to file their brief addressing all matters contained in the notice of appeal and amended notice of appeal, and that no further extensions of time will be granted for their brief.
