JOINT MOTION TO AMEND CONSENT AGREEMENT AND FINAL ORDER

The parties to the above-styled matter hereby file this Joint Motion to Amend the Consent Agreement and Final Order (CAFO) approved and finalized by the Regional Judicial Officer (RJO) on September 19, 2011, and request that the RJO issue an Order amending the CAFO to correct two typographical errors in the CAFO. Specifically, the negotiated penalty agreed to by the parties was \$14,260, to be paid in twelve installments. However, in paragraphs 26 and 31 of the CAFO, EPA incorrectly typed in the penalty amount as \$14,620. This mistake was not discovered by EPA until after the CAFO had been approved and copies were served on the parties. The parties request that the RJO issue an Order amending the CAFO by changing the amount in paragraphs 26 and 31 to \$14,260, and by further revising paragraph 26 to state that Respondent shall pay the first installment of the penalty within 30 days after the effective date of the RJO's Order granting the parties' Motion.

Respondent's president, Donald Wilshe, has advised EPA that he concurs in this Motion and has authorized the undersigned counsel for EPA to file this Joint Motion on his behalf.
