AMENDMENT

1. On February 5, 2008, the United States Environmental Protection Agency issued the above-captioned Order to address violations of the Clean Water Act by Respondent, City of Rockaway Beach, Missouri, and ordered specific actions that Respondent take to come into compliance with the Act.

2. On September 30, 2011, the Missouri Department of Natural Resources issued Missouri State Operating Permit No. MO-0108162 to Respondent for the Rockaway Beach Wastewater Treatment Plant ("Permit"). The Permit requires, among other things, that Respondent submit a report that addresses measures which Respondent has taken in the prior year to locate and eliminate sources of infiltration and inflow into the collection system serving the facility. The Permit, in effect through September 29, 2016, requires annual submission of the report on January 28th of each year.


3. Paragraph 35 of Section V of the above-captioned Order requires that Respondent submit bi-annual reports to MDNR through 2013. EPA hereby amends the above-captioned Order as follows:

Respondent shall submit annually, on January 28th of each year, a report to the Missouri Department of Natural Resources, Southwest Regional Office, that addresses measures which Respondent has taken in the prior year to locate and eliminate sources of infiltration and inflow into the collection system serving its POTW.

4. All other provisions of the Order remain in full force and effect.
