#### JOINT STATUS REPORT

This Joint Status Report is in response to your Initial Prehearing Order, dated May 20, 2010, wherein you ordered Complainant to file a fully executed Consent Agreement and Final Order (CA/FO) memorializing settlement no later than June 21, 2010.

The parties in the above-referenced case previously submitted a Joint Status Report on May 17, 2010. Since that time, the parties have reviewed and agreed to the language in the CA/FO.

The Parties are pleased to report this morning, on June 16, 2010, the Complainant has concurred (but did not sign) the Consent Agreement and Final Order (CA/FO) and the document was immediately forwarded to Respondent for signature. Respondent's counsel has informed Complainant's counsel that the Respondent has already reviewed and approved the content of the CA/FO informally. As such, the parties expect that Respondent's signatory will be able to sign and return the CA/FO to Complainant in a matter of days.

Complainant's counsel has requested that Respondent return the executed CA/FO by no later than Wednesday, June 23, 2010. At that time, Complainant's counsel will present the CA/FO to the Complainant to sign the document, and then have the Complainant's Regional Administrator sign and issue the Final Order. Complainant expects to have the CA/FO signed and issued by June 30, 2010.
