Hi Karen and John,

Thanks again for speaking with Jamie, Jane, and I about the requirements of the Emergency Administrative Order (EAO) and Jamie's separate requirements. The EAO will be emailed later this afternoon. Below is a summary of what we will need from you this weekend. We will touch base next week for everything else.

- 1) Within 24 hours of receipt of the Emergency Administrative Order, inform the EPA of your intent to comply. To complete this requirement, simply respond to the email and say "We intend to comply with the EAO" or something to that effect.
- 2) Post the boil order at the water system. As mentioned during the call, you can post it on the camp bulletin board and hand a copy to visitors of the campground upon entry. Please send us a picture of the posted boil order along with the certification page on the template that Jamie sent.
- 3) Provide an alternate source of water for the customers of the water system. This can be bottled water, water brought in by a water hauler (i.e. a water buffalo), etc...

Please feel free to reach out to me with any questions or concerns and I will be in touch next week on Tuesday to go over everything else.
