ORDER REGARDING "JOINT REPORT"

On January 7, 2010, the Court issued an "Order regarding 'Joint Informative Motion' and Respondent's 'Informative Motion,'" in which the Court granted the parties' request for thirty (30) days to file a "Joint Report" informing the Court of the status of this matter. The Court directed the parties to file the "Joint Report" by February 5, 2010, and advised the parties that, unless they were able to inform the Court that a settlement in principle had been reached by that date, the Court would require Respondent to submit its prehearing exchange within seven (7) days thereafter and schedule a hearing for March 2010.

The parties timely filed their "Joint Report" on February 4, 2010, notifying the Court that the parties had "reached an agreement in principle, dispositive of all matter[s] asserted in the Complaint." Because they "expect to have a fully-executed Consent Agreement and Final Order (CA/FO) with the next thirty (30) days," the parties seek thirty (30) days to submit this document to the Court.

Upon consideration, the Court grants the parties' request. Thirty (30) days is a reasonable period of time for the parties to file a fully executed CA/FO. Accordingly, the Court directs the parties to file a fully executed CA/FO by March 8, 2010.
