**ORDER GRANTING MOTION FOR CONTINUANCE**

By an order dated January 26, 2010, the Court denied a Joint Motion for Continuance submitted by the parties on January 15, in which the parties requested an open-ended extension to file a fully executed Consent Agreement and Final Order ("CA/FO") in this matter. Instead, the Court directed the parties to file the fully executed CA/FO by March 1, 2010. On February 22, 2010, Respondent filed a Motion for Continuance, seeking an extension to file the fully executed CA/FO. Respondent asserts that the parties have developed a draft CA/FO and draft Administrative Order on Consent ("AOC") to resolve this matter but that the parties are still finalizing the terms of these documents. Respondent "estimates that the Parties will require until March 16, 2010 to finalize and execute both the CA/FO and the AOC." Respondent relates that Complainant does not oppose its request for an extension.

Upon consideration, the Court grants Respondent's request. The period of time requested is reasonable to finalize the agreements and obtain the appropriate approval and signatures. Accordingly, the Court directs the parties to file a fully executed CA/FO by March 16, 2010. The Court trusts that the parties will make no further requests for extensions.
