On July 2, 2009, the U.S. Environmental Protection Agency (EPA) issued an Administrative Order (Order), ordering the Carter Chouteau County Water and Sewer District (Respondent), to comply with certain regulations promulgated under the federal Safe Drinking Water Act, 42 U.S.C. §§ 300f to 300j-26. The EPA's records indicate that the Respondent is in violation of the Order. Among other things, the Order included the following requirement (quoted from item 33 on page 6 of the Order):

Upon receipt of this Order, Respondent shall monitor for volatile organic chemical concentrations annually. 40 C.F.R. § 141 24(f)(5).

The Respondent did not monitor the system's water for volatile organic chemical (VOC) concentrations during 2012. The System most recently collected its VOC sample on February 11, 2013. The next VOC sample shall be collected during 2014.

The EPA is considering additional enforcement action as a result of the Respondent's non-compliance with the Order. Violating an administrative order may lead to (1) a penalty of up to \$37,500 per day per violation of the order, and/or (2) a court injunction ordering compliance.
