This letter is the EPA's written approval of your request to place the Cook Lake Campground Loop B well back into service for the 2007 season. This request was submitted to EPA in your May 16, 2007 letter to Jeff McPherson, in which you provided a status report of completed corrective action work, as required in Item Number 3 of the Order section, on page 4 of the November 14, 2006 Administrative Order (AO) referenced above. This letter confirms the verbal approval provided by Lisa Kahn of EPA in her telephone conversation with Brian Beam of the Black Hills National Forest on May 22, 2007. Since all required tasks of the AO have been completed by the Black Hills National Forest, please be advised that quarterly reports to EPA are no longer necessary.

Thank you for your diligent efforts to identify the source of contamination and complete the modifications to the well.

Please be advised that the USDA Forest Service must continue to meet the total coliform maximum contaminant level (MCL) requirements for wells providing drinking water to the public.
