# <u>Consent Agreement and Final Order</u> <u>Preliminary Statement</u>

1. This is an administrative action commenced and concluded under Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136*l*(a), and Sections 22.13(b) and 22.18(b)(2) and (3) of the *Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits* (Consolidated Rules) as codified at 40 C.F.R. Part 22.

2. The Complainant is the Director of the Enforcement & Compliance Assurance

Division, U.S. Environmental Protection Agency (EPA), Region 5.

3. Respondent is Chemtrade Electrochem Inc. (Chemtrade), a corporation doing business at 155 Gordon Baker Road in Toronto, Ontario, Canada M2H 3N5, in care of its U.S. agent, Chemtrade Electrochem U.S. Inc., a corporation doing business at 90 East Halsey Road, Parsippany, NJ 07054. 4. Where the parties agree to settle one or more causes of action before the filing of a complaint, the administrative action may be commenced and concluded simultaneously by the issuance of a consent agreement and final order (CAFO). 40 C.F.R. § 22.13(b).

5. The parties agree that settling this action without the filing of a complaint or the adjudication of any issue of fact or law is in their interest and in the public interest.

6. Respondent consents to the assessment of the civil penalty specified in this CAFO, and to the terms of this CAFO.

#### Jurisdiction and Waiver of Right to Hearing

7. Respondent admits the jurisdictional allegations in this CAFO and neither admits nor denies the factual allegations and alleged violations in this CAFO.

8. Respondent waives its right to request a hearing as provided at 40 C.F.R.

§ 22.15(c), any right to contest the allegations in this CAFO, and its right to appeal this CAFO.

9. Respondent certifies that it is complying with FIFRA, 7 U.S.C. §§ 136 to 136y.

#### **Statutory and Regulatory Background**

10. The importation of pesticides into the United States (U.S.) is governed by Sections 17(c) and (e) of FIFRA, 7 U.S.C. §§ 1360(c) and 1360(e), and the regulations promulgated there under by the Secretary of the Treasury in consultation with the Administrator of EPA. These regulations are found at 19 C.F.R. Part 12.110 *et seq*. See also 19 C.F.R. § 12.1(b).

11. 19 C.F.R. § 12.112(a) states, in pertinent part, that an importer desiring to import pesticides into the U.S. shall submit to the EPA, prior to the arrival of the shipment into the U.S., a Notice of Arrival of Pesticides (NOA) on EPA Form 3540-1 for each pesticide.

12. Section 12(a)(2)(N) of FIFRA, 7 U.S.C. § 136j(a)(2)(N), states that it is unlawful for any person who is a distributor to fail to file reports required by 7 U.S.C. Title 7, Chapter 6, Subchapter II.

13. 19 C.F.R. § 141.18 states, in pertinent part, that a nonresident corporation may not enter merchandise into the U.S. for consumption unless it has a resident agent authorized to accept service of process against the nonresident corporation.

14. The term "person" means "any individual, partnership, association, corporation, or any organized group of persons whether incorporated or not." 7 U.S.C. § 136(s).

15. The term "importer" is defined at 19 C.F.R. § 101.1 as the person primarily liable for the payment of any duties on the merchandise, or an authorized agent acting on his behalf.

16. A "pesticide" is, among other things, any substance or mixture of substances intended for preventing, destroying, repelling, or mitigating any pest. 7 U.S.C. § 136(u).

17. A "pest" is any insect, rodent, nematode, fungus, weed, or any other form of terrestrial or aquatic plant or animal life or virus, bacteria, or other micro-organism which the Administrator of EPA declares to be a pest under Section 25(c)(1) of FIFRA, 7 U.S.C. § 136(t).

18. Section 14(a)(1) of FIFRA, 7 U.S.C. § 136*l*(a)(1), states that any registrant, commercial applicator, wholesaler, dealer, retailer or other distributor who violates any provision of FIFRA may be assessed a civil penalty by EPA of not more than \$7,500 for each offense that occurred after January 12, 2009 through November 2, 2015. The Federal Civil Penalties Inflation Adjustment Act of 1990, as amended through 2015, 28 U.S.C. § 2461, and its implementing regulations at 40 C.F.R. Part 19, increased the amount that can be assessed to \$20,528 for each offense occurring after November 2, 2015 and assessed after December 23, 2020. See 85 Fed. Reg. 247 (December 23, 2020).

#### **Factual Allegations and Alleged Violations**

19. Respondent is a "person" as defined at Section 2(s) of FIFRA, 7 U.S.C. § 136(s).

20. Respondent was, at all times relevant to this CAFO, an "importer" as that term is defined in 19 C.F.R. § 101.1.

21. Chemtrade Electrochem U.S. Inc., located at 90 East Halsey Road, Parsippany, NJ 07054, at all times relevant to this CAFO, was the resident agent for Chemtrade, pursuant to 19 C.F.R. § 141.18.

22. Respondent, at all times relevant to this CAFO, was importing pesticides into the U.S.

### Entry Number E15-30461471

23. The Respondent imported **Chlorine**, EPA Reg. No. 69874-5, under Entry Number E15-30461471, which arrived into the U.S. through the International Falls, Minnesota Port of Entry on or about April 24, 2021.

24. **Chlorine**, EPA Reg. No. 69874-5, is a pesticide, as defined in Section 2(u) of FIFRA.

25. Respondent did not submit a NOA to the EPA for this shipment prior to the arrival of the shipment into the U.S.

#### Entry Number E15-30465944

26. The Respondent imported **Chlorine**, EPA Reg. No. 69874-5, under Entry Number E15-30465944, which arrived into the U.S. through the International Falls, Minnesota Port of Entry on or about May 3, 2021.

27. Respondent did not submit a NOA to the EPA for this shipment prior to the arrival of the shipment into the U.S.

### Count 1

28. The preceding paragraphs are incorporated by reference.

29. Respondent's failure to submit a NOA to the EPA for **Chlorine**, EPA Reg. No. 69874-5, Entry Number E15-30461471, prior to the arrival of the shipment into the U.S., constitutes a violation of Section 12(a)(2)(N) of FIFRA.

30. Respondent's violation of Section 12(a)(2)(N) of FIFRA subjects Respondent to the issuance of an Administrative Complaint assessing a civil penalty under Section 14(a) of FIFRA.

### Count 2

31. The preceding paragraphs are incorporated by reference.

32. Respondent's failure to submit a NOA to the EPA for **Chlorine**, EPA Reg. No. 69874-5, Entry Number E15-30465944, prior to the arrival of the shipment into the U.S., constitutes a violation of Section 12(a)(2)(N) of FIFRA.

33. Respondent's violation of Section 12(a)(2)(N) of FIFRA subjects Respondent to the issuance of an Administrative Complaint assessing a civil penalty under Section 14(a) of FIFRA.

### **Civil Penalty and Other Relief**

34. Section 14(a)(4) of FIFRA, 7 U.S.C. § 136*l*(a)(4), requires the Administrator to consider the size of the business of the person charged, the effect on the person's ability to continue in business, and the gravity of the violation, when assessing an administrative penalty under FIFRA.

35. Based on an evaluation of the facts alleged in this CAFO, the factors in Section 14(a)(4) of FIFRA and EPA's Enforcement Response Policy for the Federal Insecticide, Fungicide, and Rodenticide Act, dated December 2009, Complainant has determined the appropriate penalty to settle this action is \$17,800.

36. Within 30 days after the effective date of this CAFO, Respondent must pay a

\$17,800 civil penalty for the FIFRA violations. Respondent must pay the penalty by electronic funds transfer, payable to the "Treasurer, United States of America," and sent to:

In the comment or description field of the electronic funds transfer, state "Chemtrade Electrochem Inc. in care of its US Agent, Chemtrade Electrochem U.S. Inc." and the docket number of this CAFO.

37. Respondent must send a notice of payment that states Respondent's name and the case docket number to EPA at the following addresses when it pays the penalty:

38. This civil penalty is not deductible for federal tax purposes.

39. If Respondent does not pay the civil penalty in a timely manner, EPA may refer the matter to the Attorney General who will recover such amount by action in the appropriate United States district court under Section 14(a)(5) of FIFRA, 7 U.S.C. § 136l(a)(5). The validity, amount and appropriateness of the civil penalty are not reviewable in a collection action. 40. Pursuant to 31 C.F.R. § 901.9, Respondent must pay the following on any amount overdue under this CAFO. Interest will accrue on any amount overdue from the date payment was due at a rate established by the Secretary of the Treasury. Respondent must pay a \$15 handling charge each month that any portion of the penalty is more than 30 days past due. In addition, Respondent must pay a 6 percent per year penalty on any principal amount 90 days past due.

## **General Provisions**

Consistent with the Standing Order Authorizing E-Mail Service of Orders and Other Documents Issued by the Regional Administrator or Regional Judicial Officer under the Consolidated Rules, dated March 27, 2015, the parties consent to service of this CAFO by email at the following valid e-mail addresses for their respective representatives: Ms. Nidhi O'Meara at <u>omeara.nidhi@epa.gov</u> (attorney for Complainant), and Ms. Marissa Curran at <u>MCurran@Polsinelli.com</u> (attorney for Respondent). The parties waive their right to service by the methods specified in 40 C.F.R. § 22.6.

41. This CAFO resolves only Respondent's liability for federal civil penalties for the violations and facts alleged in this CAFO.

42. This CAFO does not affect the right of EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law.

43. This CAFO does not affect Respondent's responsibility to comply with FIFRA and other applicable federal, state, and local laws.

44. This CAFO is a "final order" for purposes of EPA's Enforcement Response Policy for FIFRA.

45. The terms of this CAFO bind Respondent, its successors, and assigns.

46. Each person signing this agreement certifies that he or she has the authority to sign for the party whom he or she represents and to bind that party to its terms.

- 47. Each party agrees to bear its own costs and attorney's fees, in this action.
- 48. This CAFO constitutes the entire agreement between the parties.
