# H and M Farms, LLC Green Ridge, MO

## UNITED STATES ENVIRONMENTAL PROTECTION AGENCY

In accordance with Section 309(g)(4)(A) of the Clean Water Act ("CWA"), 33 U.S.C. § 1319(g)(4)(A), and 40 C.F.R. § 22.45 of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits ("Consolidated Rules"), notice is hereby given that a Consent Agreement and Final Order is proposed with H and M Farms, LLC ("Respondent") regarding its animal feeding operation near Green Ridge, Missouri.

Under the CWA, the U.S. Environmental Protection Agency ("EPA") is authorized to issue orders assessing civil penalties for various violations of the CWA. EPA may issue such orders after beginning either a Class I or Class II penalty proceeding. EPA provides notice of the proposed assessment of a Class II civil penalty pursuant to Section 309 of the CWA. Class II proceedings are conducted under EPA's Consolidated Rules, 40 C.F.R. Part 22.

In this case, EPA alleges that Respondent violated Section 301 of the CWA, 33 U.S.C. § 1311, when Respondent's concentrated animal feeding operation discharged process wastewater associated with the outdoor storage and manure and poultry litter to tributaries of Elk Branch Creek and Camp Branch Creek. Respondent has reached agreement with EPA on the terms of a proposed consent agreement and final order that would resolve this matter. Under the proposed consent agreement and final order, Respondent will pay a civil penalty of \$47,700. Final approval of the proposed consent agreement and final order is subject to the requirements of 40 C.F.R. § 22.45.

EPA will receive written comments on the consent agreement and final order for a period of thirty (30) days from the date of publication of this notice. The procedures by which the public may submit written comments on a proposed Class II order or participate in a Class II proceeding and the procedures by which a respondent may request a hearing are set forth in the Consolidated Rules. Please reference Docket No. CWA-07-2014-0062. In order to provide opportunity for public comment, EPA will issue no final order assessing a penalty in this proceeding prior to forty (40) days from the date of this notice.
