Dear Commissioners:

The Safe Drinking Water Act (SDWA) requires that the Environmental Protection Agency (EPA) notify locally elected officials of certain enforcement actions taken in their area.

An Administrative Order is being issued to Grand Teton Reservations, LLC, as the owner/operator of the Elk Refuge Inn located in Jackson, Wyoming. This Order requires that the public water system take measures to return to compliance with the SDWA and the National Primary Drinking Water Regulations. The violations include failure to monitor for nitrate contamination and failure to notify EPA of the violation.

Enclosed is an Administrative Order issued by the Environmental Protection Agency (EPA) under the authority of the Safe Drinking Water Act (SDWA), 42 U.S.C. § 300f <u>et seq</u>. Among other things, the Order describes how Grand Teton Reservations, LLC (Grand Teton) has violated the National Primary Drinking Water Regulations. EPA's previous Order, Docket No. SDWA-08-2006-0026, issued to Grand Teton on April 20, 2006, remains in full force and effect.

The Order is effective upon the date received. Please review the Order and within 10 days provide EPA with any information you believe EPA may not have. If Grand Teton complies with the Order for twelve months, EPA may close the Order without further action. Failure to comply with the Order may lead to substantial civil penalties and/or a Federal court injunction ordering compliance.

Also enclosed is a small business resources information sheet, outlining compliance assistance resources and tools available to small businesses and small governments, in case these resources apply to your situation.

## ADMINISTRATIVE ORDER

Docket No. SDWA-08-2009-0070

1. This Order is issued under the authority vested in the Administrator of the United States Environmental Protection Agency (EPA) by section 1414(g) of the Safe Drinking Water Act (the Act), 42 U.S.C. § 300g-3(g), as properly delegated to the undersigned officials.

2. Grand Teton Reservations, LLC is a Wyoming corporation as of June 23, 1997, that owns and/or operates the Elk Refuge Inn Water System (the system) in Teton County, Wyoming, which provides piped water to the public for human consumption. The system is supplied by a groundwater source consisting of one untreated well and serves approximately 66 people daily through 1 service connection year round. The system is a "non-community" water system as defined in 40 C.F.R. § 141.2. Respondent is subject to the requirements of the Act and the National Primary Drinking Water Regulations (drinking water regulations), at 40 C.F.R. part 141.

# VIOLATIONS

3. Respondent is required to monitor the system's water annually for nitrate to determine compliance with the maximum contaminant level (MCL) for nitrate. 40 C.F.R. § 141.23(d). Respondent failed to monitor the water for nitrate contamination in 2006 and 2008, and, therefore, violated this requirement.

4. Respondent is required to report any failure to comply with any of the drinking water regulations (with some exceptions not applicable here) to EPA within 48 hours. 40 C.F.R. § 141.31(b). Respondent failed to report the violations listed in paragraph 3 above to EPA and, therefore, violated this requirement.

### ORDER

Based on the above violations, Respondent is ordered to perform the following actions, upon receipt of this Order by Respondent:

5. Respondent shall monitor for nitrate at least annually in accordance with the drinking water regulations. 40 C.F.R. § 141.23(d). Respondent shall report all analytical results to EPA within the first 10 days following the month in which sample results are received, or within the first 10 days following the end of the monitoring period, whichever is shortest. 40 C.F.R.

§ 141.31(a). Respondent monitored for nitrate on March 19, 2009, and has, therefore, fulfilled the 2009 monitoring requirements.

6. Respondent shall report any violation of nitrate monitoring requirements to EPA within 48 hours. 40 C.F.R. § 141.31(b).

### **GENERAL PROVISIONS**

8. This Order does not constitute a waiver, suspension, or modification of any requirement of the Act or drinking water regulations. Issuance of this Order is not an election by EPA to forgo any civil or criminal action.

9. Violation of any part of this Order, the Act, or the drinking water regulations may subject Respondent to a civil penalty of up to \$37,500 (as adjusted for inflation) per day of violation. 42 U.S.C. § 300g-3(g)(3); 40 C.F.R. part 19.
