(Respondent), (together, "the Parties") have been actively participating in good faith negotiations, including numerous meetings and conference calls in order to expedite a final settlement of this matter. The Parties have presented each other with arguments and settlement proposals.

Complainant reviewed a settlement proposal presented by Respondent which included various Supplemental Environmental Projects (SEPs). After a careful review of the SEPs proposed by Respondent, Complainant determined that such did not comply with the requirements of EPA's Supplemental Environmental Projects Policy, dated May 1, 1998, as arnended.

Respondent has alleged that it is presently going through financial hardship and has presented Complainant with financial documents in support of its claim. Complainant is currently entertaining such claim and is performing a financial analysis of the documents and information provided by Respondent. The Parties intend to meet on Wednesday, January 14, 2009, in furtherance of the negotiations efforts.

This Motion was discussed today with Roberto Passalacqua, Esq., Respondent, who agreed to the filing of this status report.
