1. Complainant and Respondent, Kawasaki Motors Manufacturing Corp., U.S.A (Kawasaki) have reached a settlement in this matter.
2. Kawasaki has the final copy of the Consent Agreement and Final Order (CAFO) as agreed upon by the parties. The Kawasaki official who will sign the document is unavailable to sign the CAFO until Monday, July 30.
3. In accordance with the Prehearing Order issued by Administrative Law Judge William B. Moran in this matter, the date for submission of prehearing exchanges is Thursday, August 2, 2007.

5. Undersigned counsel for Complainant represents that I have consulted with counsel for Respondent and he concurs with the request for an extension of time as set forth herein.


