This document is my answer to the "Administrative Complaint and Notice of Opportunity for Hearing...Docket No. TRSCA-03-2012-0015" (Complaint) completed and sent within 30 day s of my receipt of the Complaint on or about March 19, 2012.

I prepared it after I called Mr. Gregory J. Smith the attorney assigned to this case, as was suggested in the Complaint, and after I was called by Benjamin Cohan who identified himself as Mr Smith's replacement as the attorney for EPA on this matter. Mr. Smith indicated he was being replaced and said I should expect a call from Mr Cohan. I believe that a continued "let's-get-this- resolved" attitude on my part will only bring this matter closer to an railroaded adjudication by EPA's bureaucracy.
