

**STATUS REPORT AND MOTION FOR EXTENTION OF TIME**

As directed by the Administrative Law Judge (ALJ) in her Prehearing Order dated April 16, 2008, the United States Environmental Protection Agency Region 4 (EPA or Complainant) respectfully submits this status report regarding the settlement conference scheduled to occur between the Parties in this matter on or before April 25, 2008. At this time, EPA and the Respondent have been unable to meet to discuss settlement as the Respondent is attending to a terminally ill parent. Respondent seeks an extension of time to hold the settlement conference and EPA does not object to a reasonable extension. Therefore, the Parties seek an extension of thirty days to hold the settlement conference pursuant to 40 C.F.R. § 22.16. Both the Respondent and EPA believe that such a conference may be helpful in resolving this matter without the need for litigation. Additionally, due to the necessity to postpone the settlement conference, EPA would like to respectfully request that the deadlines in the Prehearing Order schedule be extended for one month as well.


