Comes now Respondent Hanson's Window and Construction, Inc., by and through its counsel, pursuant to Rule 22.7(b) of the Consolidated Rules of Practice (40 C.F.R. 22.7(b)) and respectfully requests a 30-day extension of time to file its Prehearing Exchange and as good cause therefor states as follows:

Respondent and Complainant, the United States Environmental Protection Agency, have agreed in principle to the terms of a consent decree to resolve both Docket No. TSCA-05-2010-0013 and Docket No. TSCA-05-2011-0006. Respondent and Complainant, without delay, intend to codify this agreement into a written consent decree to be filed with the Presiding Officer upon completion.

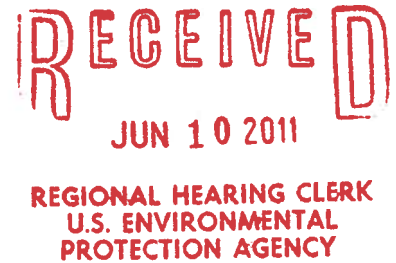
