I am glad to see that you continue to have access to your email inbox and can review my messages. I think the letter is clear and speaks for itself. In short, I encourage you to continue to work with Rick to provide EPA with the necessary financial documentation for us to fully process your inability-to-pay claim. However, that process is separate and distinct from the ongoing litigation. The next step in the litigation, as discussed in the attached letter, is for EPA to file a motion for default given that Chill Transportation LLC has failed to file an answer to our complaint within the period of time required by the federal rules. You have received the complaint numerous times, but again for your convenience it is attached to this message.

I again request that you consider signing the attached acknowledgment of electronic service. This will make future communication in the litigation less burdensome for both parties.
