Respondent, MEDFORD AUTO WRECKERS, INC., by and through its attorney, LAWRENCE J. HOLT, answering the Complaint upon information and belief, states as follows:

- 1. Respondent admits paragraphs numbered "14" and "15" of the Findings of Fact.
- 2. Pursuant to paragraph numbered "17" of the Findings of Fact, Respondent advises that the Respondent purchased a machine to reclaim or recycle refrigerants in 1996 and wishes to correct the information that they did not purchase a machine.
- 3. Respondent admits paragraph numbered "18" of the Findings of Fact, except that the approximate number of vehicles received is between three (3) and five (5) per week.
 - 4. Respondent admits paragraph numbered "19" of the Findings of Fact.
- 5. Pursuant to paragraph numbered "20" of the Findings of Fact, Respondent states that they did not keep a separate record of the information regarding the refrigerant removed or evacuated from the vehicles, but have a list of each vehicle that entered their facility. Respondent entered into an Agreement with two (2) Corporations duly licensed to remove and evacuate refrigerant from cars. These Corporations have given to the

Respondent, a statement to such effect and that this is made a part of the Answer as Exhibit "A".

6. Pursuant to paragraphs numbered "22" and "23" of the Findings of Fact, Respondent participated in a television episode called "Dirty Jobs" and was requested to provide an example of how refrigerant could escape into the atmosphere. Respondent's employee demonstrated by first cutting the valve in which freon would be stored. After this was done, since freon had been evacuated from the area, water was provided and the engine started and what was shown on the television screen was compressed air going into the atmosphere. Respondent vehemently denies that the release caused by the episode of "Dirty Jobs" did not release any freon into the atmosphere, but as stated above, only compressed air (Exhibit "B" attached hereto).

Please be aware that the above mentioned vehicle used during Medford Auto Wreckers, Inc., segment on the television show "Dirty Jobs" was already fully prepped prior to filming the show. To define "fully prepped" this means: the battery, fuel tank, rims and tires were already removed. The freon is also, evacuated during this prep process to ensure that no vehicle gets stored nor dismantled without meeting this process.

Per the requests of the filming crew, we were to "boost" up the segment in any way possible. For example, we plumbed air with water, directly into the air conditioning system. The air was supplied by a hose connected to the systems receiver/dryer. This idea is similar to making artificial snow. Many parts of the show were fabricated at the request of the film crew. Other examples being: the breaking of a full, good door glass just to retrieve a rearview mirror, along with cutting the top bolt of an alternator with a torch instead of using proper tools to remove the part. This needed to be entertaining as well as some what knowledgeable.
