ORDER EXTENDING DEADLINE FOR DECIDING WHETHER TO EXERCISE SUA SPONTE REVIEW

On December 1, 2015, Administrative Law Judge M. Lisa Buschmann issued an Initial Decision and Order in the above-captioned matter. On January 13, 2016, counsel for Respondents filed a motion with the Environmental Appeals Board ("Board") requesting to file a notice of appeal.

The Board hereby extends its deadline for deciding whether to review the Initial Decision and Order on its own initiative, i.e., sua spoute, under 40 C.F.R. § 22.30(b) until thirty (30) days after the Board rules on Respondents' motion. The Region shall file a response to Respondents' motion no later than Monday, February 1, 2016. Respondents shall file any reply in support of their motion no later than Tuesday, February 16, 2016. See 40 C.F.R. § 22.16(b); id. § 22.7(a).
