#### Consent Agreement and Final Order

#### **Preliminary Statement**

- 1. This is an administrative action commenced and concluded under Section 14(a) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), 7 U.S.C. § 136*l*(a), and Sections 22.13(b) and 22.18(b)(2) and (3) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties and the Revocation/Termination or Suspension of Permits (Consolidated Rules) as codified at 40 C.F.R. Part 22.
- 2. The Complainant is the Director of the Enforcement and Compliance Assurance Division, U.S. Environmental Protection Agency (EPA), Region 5.
- 3. The Respondent is Stepan Company (Stepan), a corporation doing business in the State of Illinois.
- 4. Where the parties agree to settle one or more causes of action before the filing of a complaint, the administrative action may be commenced and concluded simultaneously by the issuance of a consent agreement and final order (CAFO). 40 C.F.R. § 22.13(b).
- 5. The parties agree that settling this action without the filing of a complaint or the adjudication of any issue of fact or law is in their interest and in the public interest.

6. Respondent consents to the assessment of the civil penalty specified in this CAFO, and to the terms of this CAFO.

#### Jurisdiction and Waiver of Rights

- 7. Respondent admits the jurisdictional allegations in this CAFO and neither admits nor denies the factual allegations in this CAFO.
- 8. Respondent waives its right to request a hearing as provided at 40 C.F.R. § 22.15(c), any right to contest the allegations in this CAFO, and its right to appeal this CAFO. Respondent waives any rights or defenses that Respondent has or may have for this matter to be resolved in federal court, including but not limited to any right to a jury trial. Respondent waives any right to challenge the lawfulness of the final order accompanying the consent agreement and waives its right to appeal the final order accompanying the consent agreement.
  - 9. Respondent certifies it is complying with FIFRA, 7 U.S.C. §§ 136 to 136y.

#### Statutory and Regulatory Background

- 10. Section 3(c)(1)(C) of FIFRA, 7 U.S.C. § 136a(c)(1)(C), states that each applicant for registration of a pesticide shall file with the Administrator a statement which includes a complete copy of the labeling of the pesticides, a statement of all claims to be made for it, and any directions for its use.
- 11. Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E), states that it is unlawful for any person to distribute or sell to any person any pesticide which is misbranded.
- 12. Section 2(q)(1)(A) of FIFRA, 7 U.S.C. § 136(q)(1)(A), defines a pesticide as "misbranded" if its labeling bears any statement, design, or graphic representation relative thereto or to its ingredients which is false or misleading in any particular.

- 13. Section 2(q)(1)(F) of FIFRA, 7 U.S.C. § 136(q)(1)(F), defines a pesticide as "misbranded," in pertinent part, if the labeling accompanying it does not contain directions for use which are necessary for effecting the purpose for which the product is intended.
- 14. 40 C.F.R. Part 152 sets forth the pesticide registration and classification procedures concerning registration of pesticide products under Section 3 of FIFRA.
- 15. 40 C.F.R. § 152.132 states that a registrant may distribute or sell his registered product under another person's name and address instead of (or in addition to) his own. The product is referred to as a "distributor product."
- 16. 40 C.F.R. § 152.132 states that supplemental distribution is permitted upon notification to the Agency if all of the following conditions are met: (a) The registrant has submitted to the Agency for each distributor product a statement signed by both the registrant and the distributor listing the names and addresses of the registrant and the distributor, the distributor's company number, the additional brand name(s) to be used, and the registration number of the registered product, (b) The distributor product is produced, packaged and labeled in a registered establishment operated by the same producer who produces, packages, and labels the registered product, (c) The distributor product is not repackaged (remains in the producer's unopened containers), (d) The label of the distributor product is the same as that of the registered product, except that the product name of the distributor product may be different, the name and address of the distributor may appear instead of that of the registrant, the registration number of the registered product must be followed by a dash, followed by the distributor's company number, the establishment number must be that of the final establishment at which the product was produced, and specific claims may be deleted, provided that no other changes are necessary,

- and (e) Voluntary cancellation of a product applies to the registered product and all distributor products distributed or sold under that registration number.
- 17. 40 C.F.R. § 152.132 states that a distributor is considered an agent of the registrant for all intents and purposes under FIFRA, and both the registrant and the distributor may be held liable for violations pertaining to the distributor product.
- 18. 40 C.F.R. § 156.10(a)(5) states a pesticide is misbranded if its labeling is false or misleading in any particular including both pesticidal and non-pesticidal claims. Examples include: "(ii) A false or misleading statement concerning the effectiveness of the product as a pesticide . . . (iv) A false or misleading comparison with other pesticides . . . (v) Any statement directly or indirectly implying the pesticide is recommended or endorsed by any agency of the Federal Government . . . (ix) Claims as to the safety of the pesticide or its ingredients, including statements such as 'safe,' 'nonpoisonous,' 'harmless' or 'nontoxic to humans and pets' with or without such a qualifying phrase as 'when used as directed.'"
- 19. 40 C.F.R. § 156.10(a)(6) states that the final printed labeling must be submitted and accepted prior to registration.
- 20. The term "distribute or sell" as defined in Section 2(gg) of FIFRA, 7 U.S.C. § 136(gg), means to distribute, sell, offer for sale, hold for distribution, hold for sale, hold for shipment, ship, deliver for shipment, release for shipment, or receive and (having so received) deliver or offer to deliver.
- 21. The term "labeling," as defined in Section 2(p) of FIFRA, 7 U.S.C. § 136(p), means all labels and all other written, printed, or graphic matter— (A) accompanying the pesticide or device at any time; or (B) to which reference is made on the label or in literature accompanying the pesticide or device except to current official publications of the

Environmental Protection Agency, the United States Departments of Agriculture and Interior, the Department of Health and Human Services, State experiment stations, State agricultural colleges, and other similar Federal or State institutions or agencies authorized by law to conduct research in the field of pesticides.

- 22. The term "person," as defined in Section 2(s) of FIFRA, 7 U.S.C. § 136(s), means any individual, partnership, association, corporation, or any organized group of persons whether incorporated or not.
- 23. A "pest," as defined in Section 2(t) of FIFRA, 7 U.S.C. § 136(t), means any insect, rodent, nematode, fungus, weed, or any other form of terrestrial or aquatic plant or animal life or virus, bacteria, or other micro-organism which the Administrator of EPA declares to be a pest under Section 25(c)(1) of FIFRA.
- 24. A "pesticide," as defined in Section 2(u) of FIFRA, 7 U.S.C. § 136(u), means, among other things, any substance or mixture of substances intended for preventing, destroying, repelling, or mitigating any pest.
- 25. A "registrant," as defined in Section 2(y) of FIFRA, § 136(y), means, a person who has registered any product pursuant to the provisions of FIFRA.
- 26. Section 14(a)(1) of FIFRA, 7 U.S.C. § 136*l*(a)(1), and 40 C.F.R. Part 19, provides that any registrant, commercial applicator, wholesaler, dealer, retailer or other distributor who violates any provision of FIFRA may be assessed a civil penalty by EPA of up to \$24,885 for each offense where penalties are assessed on or after January 8, 2025.

#### Factual Allegations and Alleged Violations

27. Respondent is a "person" as defined at Section 2(s) of FIFRA because Stepan is a corporation.

- 28. Respondent is a "registrant" as defined at Section 2(y) of FIFRA.
- 29. At all times relevant to the CAFO, Respondent owned or operated a place of business located at 1101 Skokie Boulevard, Suite 500, Northbrook, Illinois 60062.
- 30. On or about April 23, 2007, Respondent registered its pesticide product, **Stepan Disinfectant Wipe** with EPA.
- 31. EPA assigned EPA Registration Number (EPA Reg. No.) 1839-190 to the pesticide product, **Stepan Disinfectant Wipe**.
- 32. On or about March 10, 2022, EPA approved an amended label for **Stepan Disinfectant Wipe**, EPA Reg. No. 1839-190, which superseded all previously accepted labels for the pesticide product (Accepted Label) and specified that the Respondent may only distribute or sell **Stepan Disinfectant Wipe**, EPA Reg. No. 1839-190, if it bears the Accepted Label.
- 33. On or about April 1, 2015, EPA approved a Notice of Supplemental Distribution of Registered Pesticide Product (Notice of Supplemental Distribution) for **Stepan Disinfectant**Wipe, EPA Reg. No. 1839-190.
- 34. The Notice of Supplemental Distribution listed the distributor of **Stepan Disinfectant Wipe**, EPA Reg. No. 1839-190, as Wipes, LLC, now located at 24059 W. 10 Mile Road, Southfield, Michigan 48033-3005.
- 35. The Notice of Supplemental Distribution listed the distributor product name for **Stepan Disinfectant Wipe**, EPA Reg. No. 1839-190, as **Wipes.Com Disinfectant Wipes**.
  - 36. EPA assigned company number 86745 to Wipes, LLC.
- 37. The EPA Reg. No. for the distributor product, **Wipes.Com Disinfectant Wipes**, is 1839-190-86745.

- 38. **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, is a "pesticide" as that term is defined in Section 2(u) of FIFRA.
- 39. Wipes, LLC, is an agent of the registrant, Respondent, for all intents and purposes under FIFRA with respect to its distributor product **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745.
- 40. On or about November 13, 2024, inspectors employed by EPA and authorized to conduct inspections under FIFRA conducted an inspection at Wipes LLC, located at 24059 W. 10 Mile Road, Southfield, Michigan.
- 41. During the inspection, the inspectors observed cartons of **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, held in the warehouse in both four 800-count rolls and one 800-count roll in a bucket dispenser.
- 42. The inspectors inspected one case of the four 800-count rolls and observed that the outer box included the Wipes LLC website, Wipes.com, on it.
- 43. Each 800-count roll was sealed in a plastic bag and also included the Wipes LLC website, Wipes.com, on it.
- 44. The inspectors also inspected a case containing one 800-count roll in a bucket dispenser.
- 45. The outer case of the bucket dispenser and the actual bucket also included the Wipes LLC website, Wipes.com, on it.
- 46. During the inspection, the inspectors collected product labels and associated distribution and sales records for **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745.

- 47. The product labels collected during the inspection were true and accurate representations of the labels on the products that were released for distribution or sale from on or about October 13, 2024 through November 13, 2024.
- 48. At all times relevant to this CAFO, the language on the **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, product labels (on all versions of the product), did not match the Accepted Label, as follows: <sup>1</sup>
  - a. The language "A potable water rinse is required for surfaces in direct contact with food" was not present on the product labels.
  - b. When listing the varying micro-organisms the product is effective against, the product labels failed to include the applicable contact time for each microorganism listed.
  - c. When listing the varying virucide properties, the product labels included the incorrect contact times for listed micro-organisms.
  - d. When listing special instructions for cleaning and decontaminating against HIV-1, HBV and BCV of surfaces/objects soiled with blood/body fluids, the product labels included the incorrect contact time.
- 49. At all times relevant to this CAFO, the language on the **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, product labels for the bucket version also did not match
  the Accepted Label, as follows:<sup>2</sup>

- a. The product label claims that the product kills "SALMONELLA" and "FLU VIRUS" in 15 seconds. The Accepted Label lists the contact time for these microorganisms as 2 minutes.
- b. The product label failed to include the required disclaimer language "When using on food contact surfaces: thoroughly rinse all treated surfaces with potable (tap) water" for the following use sites: Delicatessens; Catering Facilities and Banquet Halls.
- c. The product label failed to include required disclaimers which were identified in footnotes 3 and 7 of the approved label associated with the following language:
   "This product will clean and disinfect<sup>3</sup> hard, non-porous surfaces ... appliance exteriors<sup>7</sup> ... stove tops<sup>7</sup>.
  - <sup>3</sup> When used according to disinfection directions ...
  - <sup>7</sup> Allow surfaces to come to room temperature prior to treatment"
- d. The directions for use failed to include the following language for labels that list medical premises and metal and/or stainless-steel surfaces: "A potable water rinse is required for surfaces in direct contact with food."
- 50. From on or about October 13, 2024 through November 13, 2024, the product labels for **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, were misbranded under Section 2(q)(1)(F) of FIFRA.
- 51. At all times relevant to this CAFO, the following language appeared on the Wipes, LLC website, Wipes.com, regarding all versions of **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745:

- a. Stop relying on old school Clorox wipes. EPA-approved disinfectant wipes more effective for COVID-19 and today's cleaning protocols.
- b. Are EPA-registered disinfectant wipes safe to use on the skin?

  The use of EPA-registered wipes for skin depends on the classification given to the product. The EPA registers products that are safe for human applications. [...]

  The effectiveness of QACs is undeniable. According to one study, disinfectants containing QACs as their active ingredient can deactivate COVID-19 in as little as 15-30 seconds. No other EPA disinfectants kill COVID-19 as fast as QAC-powered products.
- c. Place your order for our EPA wipes, and we will get you your shipments faster than the competition.
- d. Reduce Sick Days Sick days disrupt your business, causing economic strain.
  Approximately 7.8 million Americans in January 2022 had an illness-related work absence. Cut those numbers in half by reducing spread of illnesses with EPA disinfectant wipes.
- e. What chemicals are included in EPA wipes?

  You're getting quality, safety and efficacy when you purchase our wipes.
- f. Antibacterial wipes from Wipes.com are designed to reduce or eradicate bacteria from non-porous surfaces.
- g. Mitigate Disease Transmission COVID-19 is not the only airborne or surfaceborne source of illness. Using powerful fitness wipes is a proven way to save your members and staff from getting sick by eliminating sources of transmission.

- h. What chemicals are included in your gym wipes?
  Wipes.com disposable gym wipes use the most potent and safe chemicals to eliminate and destroy bacteria and viruses by attacking their lipid envelopes and membranes. Quaternary ammonium compounds (QACs) are the active ingredient, working to eliminate and deactivate viruses and bacteria in seconds.
  QACs are also proven to destroy COVID-19 lingering on gym surfaces.
- i. What's the difference between a sanitizing wipe and a disinfecting wipe? Sanitizing products are designed to reduce the presence and concentration of bacteria on a surface. Disinfectants are used to eliminate bacteria and viruses on surfaces entirely. To put it simply, disinfectants are more powerful. Some products contain both sanitizing and disinfecting qualities, with bleach being the most common example.
- 52. From on or about October 13, 2024 through November 13, 2024, the labeling for Wipes.Com Disinfectant Wipes, EPA Reg. No. 1839-190-86745, was misbranded under Section 2(q)(1)(A) of FIFRA because the above language found on Wipes.com<sup>3</sup> was false or misleading. See 40 C.F.R. § 156.10(a)(5)(ii), (iv), (v) and (ix).
- 53. From on or about October 13, 2024 through November 13, 2024, Wipes, LLC, an agent of the Respondent, distributed or sold **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, to customers in the United States, on 303 separate occasions. See Attachment A, incorporated by reference as though fully set forth herein.

#### Counts 1 through 303

54. The preceding paragraphs are incorporated by reference.

- 55. From on or about October 13, 2024 through November 13, 2024, Wipes, LLC, an agent of Respondent, distributed or sold **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, on 303 separate occasions that were misbranded as that term is defined by Section 2(q)(1)(A) and (F) of FIFRA, 7 U.S.C. § 136(q)(1)(A) and (F), and 40 C.F.R. § 156.10(a)(5)(ii), (iv), (v) and (ix).
- 56. Such distributions and sales of **Wipes.Com Disinfectant Wipes**, EPA Reg. No. 1839-190-86745, constitutes 303 separate unlawful acts pursuant to Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E).
- 57. As an agent of the Respondent, Wipes, LLC's violation of Section 12(a)(1)(E) of FIFRA, 7 U.S.C. § 136j(a)(1)(E), subjects Respondent to the issuance of an Administrative Complaint assessing a civil penalty under Section 14(a) of the FIFRA, 7 U.S.C. § 136*l*(a), for each of the 303 violations.

#### Civil Penalty and Other Relief

- 58. Pursuant to Section 14(a)(4) of FIFRA, 7 U.S.C. § 136*l*(a)(4), Complainant has determined that an appropriate civil penalty to settle this action is \$1,126,404. In determining the penalty amount, Complainant considered the appropriateness of the penalty to the size of Respondent's business and the effect on Respondent's ability to continue in business.

  Complainant also considered EPA's FIFRA Enforcement Response Policy, dated December 2009.
- 59. Respondent agrees to pay a civil penalty in the amount of \$1,126,404 ("Assessed Penalty") within thirty (30) days after the effective date of this CAFO.
- 60. Respondent shall pay the Assessed Penalty and any interest, fees, and other charges due using any method, or combination of appropriate methods, as provided on the EPA

website: https://www.epa.gov/financial/makepayment. For additional instructions see: https://www.epa.gov/financial/additional-instructions-making-payments-epa.

- 61. When making a payment, Respondent shall:
  - a. Identify every payment with Respondent's name and the docket number of this CAFO, FIFRA-05-2025-0015.
  - b. Concurrently with any payment or within 24 hours of any payment, Respondent shall serve proof of such payment to the following person(s):

"Proof of payment" means, as applicable, a copy of the check, confirmation of credit card or debit card payment, or confirmation of wire or automated clearinghouse transfer, and any other information required to demonstrate that payment has been made according to EPA requirements, in the amount due, and identified with the appropriate docket number and Respondent's name.

62. <u>Interest, Charges, and Penalties on Late Payments.</u> Pursuant to 31 U.S.C. § 3717, 31 C.F.R. § 901.9, and 40 C.F.R. § 13.11, if Respondent fails to timely pay any portion of the

Assessed Penalty, interest, or other charges and penalties per this CAFO, the entire unpaid balance of the Assessed Penalty and all accrued interest shall become immediately due and owing, and EPA is authorized to recover the following amounts.

- a. <u>Interest.</u> Interest begins to accrue from the effective date of this CAFO. If the Assessed Penalty is paid in full within thirty (30) days, interest accrued is waived. If the Assessed Penalty is not paid in full within thirty (30) days, interest will continue to accrue until any unpaid portion of the Assessed Penalty as well as any interest, penalties, and other charges are paid in full. To protect the interests of the United States the rate of interest is set at the IRS standard underpayment rate, any lower rate would fail to provide Respondent adequate incentive for timely payment.
- b. <u>Handling Charges.</u> Respondent will be assessed monthly a charge to cover EPA's costs of processing and handling overdue debts.
- c. <u>Late Payment Penalty.</u> A late payment penalty of six percent (6%) per annum, will be assessed monthly on all debts, including any portion of the Assessed Penalty, interest, penalties, and other charges, that remain delinquent more than ninety (90) days.
- 63. <u>Late Penalty Actions.</u> In addition to the amounts described in the prior Paragraph, if Respondent fails to timely pay any portion of the Assessed Penalty, interest, or other charges and penalties per this CAFO, EPA may take additional actions. Such actions EPA may take include, but are not limited to, the following.
  - a. Refer the debt to a credit reporting agency or a collection agency pursuant to 40
     C.F.R. §§ 13.13 and 13.14.

- b. Collect the debt by administrative offset (i.e., the withholding of money payable by the United States government to, or held by the United States government for, a person to satisfy the debt the person owes the United States government), which includes, but is not limited to, referral to the Internal Revenue Service for offset against income tax refunds, 40 C.F.R. Part 13, Subparts C and H.
- c. Suspend or revoke Respondent's licenses or other privileges, or suspend or disqualify Respondent from doing business with EPA or engaging in programs EPA sponsors or funds, 40 C.F.R. § 13.17.
- d. Request that the Attorney General bring a civil action in the appropriate district court to recover the amount outstanding pursuant to 7 U.S.C.§ 136l(a)(5).
- 64. Allocation of Payments. Pursuant to 31 C.F.R. § 901.9(f) and 40 C.F.R. § 13.11(d), a partial payment of debt will be applied first to outstanding handling charges, second to late penalty charges, third to accrued interest, and last to the principal that is the outstanding Assessed Penalty amount.
- 65. <u>Tax Treatment of Penalties.</u> Penalties, interest, and other charges paid pursuant to this CAFO shall not be deductible for purposes of federal taxes.
- 66. Pursuant to 26 U.S.C. § 6050X and 26 C.F.R. § 1.6050X-1, EPA is required to send to the Internal Revenue Service ("IRS") annually, a completed IRS Form 1098-F ("Fines, Penalties, and Other Amounts") with respect to any court order or settlement agreement (including administrative settlements), that require a payor to pay an aggregate amount that EPA reasonably believes will be equal to, or in excess of, \$50,000 for the payor's violation of any law or the investigation or inquiry into the payor's potential violation of any law, including amounts

paid for "restitution or remediation of property" or to come "into compliance with a law." EPA is further required to furnish a written statement, which provides the same information provided to the IRS, to each payor (i.e., a copy of IRS Form 1098-F). Failure to comply with providing IRS Form W-9 or Tax Identification Number ("TIN"), as described below, may subject Respondent to a penalty, per 26 U.S.C. § 6723, 26 U.S.C. § 6724(d)(3), and 26 C.F.R. § 301.6723-1. In order to provide EPA with sufficient information to enable it to fulfill these obligations, EPA herein requires, and Respondent herein agrees, that:

- a. Respondent shall complete an IRS Form W-9 ("Request for Taxpayer Identification Number and Certification"), which is available at <a href="https://www.irs.gov/pub/irs-pdf/fw9.pdf">https://www.irs.gov/pub/irs-pdf/fw9.pdf</a>;
- Respondent shall therein certify that its completed IRS Form W-9 includes
   Respondent's correct TIN or that Respondent has applied and is waiting for issuance of a TIN;
- c. Respondent shall email its completed Form W-9 to Milton Wise at EPA's Cincinnati Finance Center at wise.milton@epa.gov, within 30 days after the effective date of this CAFO, and EPA recommends encrypting IRS Form W-9 email correspondence; and
- d. In the event that that Respondent has certified in its completed IRS Form W-9 that it does not yet have a TIN but has applied for a TIN, Respondent shall provide EPA's Cincinnati Finance Center with Respondent's TIN, via email, within five (5) days of Respondent's receipt of a TIN issued by the IRS.

#### **General Provisions**

- 67. The parties consent to service of this CAFO by e-mail at the following valid e-mail addresses: Nidhi O'Meara at omeara.nidhi@epa.gov (counsel for Complainant), and Russ Garrison at rgarrison@stepan.com (counsel for Respondent). Respondent understands that the CAFO will become publicly available upon filing.
- 68. The Respondent's full compliance with this CAFO resolves only Respondent's liability for federal civil penalties for the violations alleged in the CAFO.
- 69. This CAFO does not affect the right of EPA or the United States to pursue appropriate injunctive or other equitable relief or criminal sanctions for any violations of law.
- 70. This CAFO does not affect Respondent's responsibility to comply with FIFRA and other applicable federal, state, and local laws.
- 71. This CAFO is a "final order" for purposes of EPA's Enforcement Response Policy for FIFRA.
  - 72. The terms of this CAFO bind Respondent, its successors, and assigns.
- 73. Each person signing this agreement certifies that he or she has the authority to sign for the party whom he or she represents and to bind that party to its terms.
  - 74. Each party agrees to bear its own costs and attorney's fees, in this action.
  - 75. This CAFO constitutes the entire agreement between the parties.
