Dear Mr. Kachuroi and Mr. Evert:

This letter is to inform you of the U.S. Environmental Protection Agency's (EPA's) decision to close the Administrative Order for Compliance on Consent (Order), Docket No. CWA-08-2014-0029, issued to Arnegard Holdings, LLC; Arnegard WW Holdings, LLC; and the City of Arnegard on August 22, 2014. The EPA has determined that Arnegard Holdings, LLC; Arnegard WW Holdings, LLC; and the City of Arnegard have no remaining obligations under the Order and, therefore, is closing the Order at this time.

Please be aware that Arnegard Holdings, LLC; Arnegard WW Holdings, LLC; and the City of Arnegard are still required to comply with the Clean Water Act (Act) and its implementing regulations, including the disposal of sewage sludge requirements pursuant to section 405 of the Act, 33 U.S.C. § 1345, and 40 C.F.R. part 503. Violations of the Act or its implementing regulations may result in a court-imposed injunction and/or penalties of up to \$51,570 per day for each violation.
