JOINT MOTION FOR ONE-WEEK EXTENSION FOR SUBMISSION OF PRE-HEARING EXCHANGES DUE TO UNAVAILABILITY OF REGIONAL PRESIDING OFFICER

Pursuant to the provisions of 40 C.F.R. § 22.7(b) of the Consolidated Rules of Practice Governing the Administrative Assessment of Civil Penalties, counsel for Complainant, the United States Environmental Protection Agency, joined by Respondent's counsel as set forth below, moves for a seven (7) day extension of time to the December 16, 2011, deadline for submission of Complainant's Prehearing Exchange set forth in the Chief Administrative Law Judge's November 3, 2011 Prehearing Order for the above-referenced matter. Complainant, joined by Respondent's counsel, further moves for a seven (7) day extension for filing of Respondent's Prehearing Exchange. If the Chief Administrative Law Judge grants this motion, the new deadline for filing of Complainant's Prehearing Exchange, or in the alternative, filing of a Consent Agreement and Final Order with the Regional Hearing Clerk, would be December 23, 2011, and the new deadline for filing of Respondent's Prehearing Exchange. If and Final Order is not filed with the Regional Hearing Clerk by December 23, 2011, would be January 13, 2012.

The reason for this motion is the unavailability of the Regional Judicial Officer/Presiding Officer for EPA Region III during the week of December 12 through 16, 2011, who this week notified the Office of Regional Counsel that she is scheduled to work on only one day next week (Tuesday, December 13, 2011). Complainant, on this day, proffered a Consent Agreement and proposed Final Order to Respondent to resolve the matter, such Consent Agreement and proposed Final Order having been drafted with the expectation that the Regional Judicial Officer would be available throughout the week of December 12. Given the Regional Judicial Officer's unavailability, the one-week extension is necessary to afford Respondent reasonable time to review the Consent Agreement and time to deliver the signed original Consent Agreement to Complainant for presentation to the Regional Judicial Officer for her approval when she returns to work during the week of December 19, 2011.

Complainant has discussed this proposed Motion with Respondent's counsel who has reviewed it, approved it, and given Complainant's counsel permission to represent that Respondent's counsel joins this motion.

WHEREFORE Complainant and Respondent now hereby move for a seven (7) day extension to the deadlines for both parties to file its prehearing exchange or for filing of a Consent Agreement and Final Order with the Regional Hearing Clerk, as set forth in the Chief Administrative Law Judge's Prehearing Order.
