ORDER

This matter is before the Presiding Officer on Complainant's Motion for Default. Clarification is needed as to two issues. First, clarification is needed as to how Complainant calculated the DNC (Days of Noncompliance) Multiplier before and after 1/12/2009. It is unclear why the DNC Multiplier before 1/12/2009 is 6 and why the DNC Multiplier after 1/12/2009 is 0.5. Second, clarification is needed as to how Complainant calculated the Economic Benefit to Respondents under Count III. It is unclear how Complainant arrived at an economic benefit amount of \$5,016.00.

Therefore, Complainant is hereby ORDERED TO SUPPLEMENT THE

RECORD on or before July 23rd, 2013, with respect to how the DNC calculations were determined and how the economic benefit calculation under Count III was performed.


