Dear David and Susan.

Thank you for assisting your clients, Glen Rogers PSD and Ravenclyff, McGraws, Saulsville PSD ("RMS"), in taking advantage of the Opportunity to Confer about the Administrative Order that EPA issued, U.S. EPA Docket No. SDWA-03-2022-0056DS, ("Order" or "Compliance Order").

Leah Zedella and I have held two phone calls with you:

1. The first on April 7, 2022, along with Pat Armstrong, the President of Glen Rogers PSD, where we discussed the relationship between Glen Rogers and RMS, and their operating agreement.
2. The second call occurred today, April 12, 2022, and included Guy Wyatt, who does the sampling for RMS, and Dan Mace from the West Virginia Department of Health and Human Resources ("WVDHHR"). During today's call we carefully reviewed the requirements of the compliance Order and their deadlines.

We agreed to the following clarifications regarding submission of deliverables to the State:

1. Under paragraph 61.a., Glen Rogers will fax sample results to WVDHHR, in accordance with state requirements.
2. Under 61.b., Glen Rogers will fax the proposed sampling plan to the WVDHHR's Beckley office, and will email a courtesy to Dan Mace.

In addition, you asked me to direct you to the appeals procedure, so that you could advise your client. If Glen Rogers wishes to seek federal judicial review of this Compliance Order, it would do so pursuant to 42 U.S.C. § 300j-7(a).

Finally, we confirmed that we have answered your questions, and that today would conclude the conference period provided in paragraph 73 of the Compliance Order. Pursuant to that same paragraph, the Order will become effective 10 days after today's conference, or on April 22, 2022 (coincidentally, on Earth Day).

As discussed, Leah and I remain available if you have questions as Glen Rogers and RMS are implementing the Compliance Order.

I am copying the Regional Hearing Clerk, so that she can place a copy of this communication in the file for this Order.
