This letter is to inform you of the United States Environmental Protection Agency's (EPA) decision to close the Administrative Order (Order), issued on July 23, 2008 to Rocky Mountain Rentals, Inc., owner of the Lakeview Mobile Home Park public water system. The EPA has determined that Rocky Mountain Rentals, Inc. has complied with the terms of the Order and therefore we will close the Order at this time.

Please be aware that Rocky Mountain Rentals, Inc. is still required to comply with the National Primary Drinking Water Regulations (NPDWR), 40 C.F.R. part 141. Violation of the NPDWRs may result in a court-imposed injunction and penalties of up to \$37,500 per day of violation.
