COMPLAINANT'S SECOND STATUS REPORT

Pursuant to this Court's Prehearing Order dated April 9, 2012, Complainant United States Environmental Protection Agency ("EPA"), submits this report regarding the status of settlement. EPA and Respondent Summit Cold Storage (hereinafter "Parties"), are working diligently on mediation efforts. As previously reported the Parties selected the mediator, James Kohanek, to assist in the settlement process. The Parties had a joint preliminary call with Mr. Kohanek on May 3, 2012 to set up individual calls as well as a face-to-face meeting. Individual calls were conducted the following week and on May 16th, the Parties held their first substantive mediation session in Chicago. While the Parties made progress toward settlement, no settlement has been achieved at this point. EPA requested additional financial information to further consider Respondent's inability to pay claim. Respondent's counsel informed EPA it hopes to provide additional financial information as well as information on a Supplemental Environmental Project by May 24th. EPA will then evaluate the information. The Parties will continue to diligently work on mediation efforts.
