**FOURTH ASSENTED-TO MOTION TO EXTEND TIME FOR  
RESPONDENT’S ANSWER AND REQUEST FOR HEARING**

Respondent Cascades Boxboard Group – Connecticut LLC (“Cascades”) hereby moves pursuant to 40 C.F.R. § 22.7 to extend the time for it to file its answer and request a hearing in the above-captioned enforcement action for forty-five (45) days to March 31, 2011.

As grounds and in support of its motion, Cascades states the following:

1. Enforcement counsel for the United States Environmental Protection Agency (“EPA”) has assented to this motion, and agreed to the March 31, 2011 date.
2. Cascades was served EPA’s Administrative Complaint and Notice of Opportunity for Hearing (“Complaint”) in the above-captioned enforcement action on or about September 27, 2010.
3. The Regional Judicial Officer allowed Cascades’ Third Assented-to Motion to Extend Time for Respondent’s Answer and Request for Hearing, dated December 22, 2010, and extended the time for Cascades to answer EPA’s Complaint and request a hearing to February 14, 2011.

4. Cascades and EPA are working on finalizing the terms for a Supplemental Environmental Program Proposal.

5. Cascades and EPA continue to negotiate a settlement during the last forty-five (45) days and believe that an additional forty-five (45) days will allow them to resolve this matter without need for the filing of an answer or holding a hearing.


WHEREFORE, Cascades Boxboard Group – Connecticut LLC respectfully requests that the Regional Judicial Officer


