
On October 11, 2016, representatives of the United States Environmental Protection Agency, the United States Fish and Wildlife Service, and the Wyoming Department of Environmental Quality conducted an inspection at the H2O Management Solutions – Commercial Oilfield Waste Disposal Facility located in Sweetwater County, Wyoming (Facility), to determine compliance with the above-referenced order (Order) and assess environmental conditions relating to H2O Management Solutions' management of solid waste at the Facility. No significant environmental concerns were observed by the inspectors on October 11, 2016.

On October 3, 2016, the USEPA received H2O Management Solutions' 2016 3rd Quarter Report, dated October 3, 2016, submitted in compliance with paragraph V.E.3. of the Order. No environmental or compliance concerns were noted in this quarterly report.

Based upon observations made during this and other inspections conducted since issuance of the Order on September 28, 2012, and the information submitted in the quarterly progress reports, the USEPA has determined that there has been no significant deterioration in environmental conditions at the Facility since the initial work to be performed pursuant to the Order was completed. Therefore, pursuant to section XXII of the Order, the USEPA is hereby terminating the Order. We direct your attention to section XI of the Order for a description of H2O Management Solutions' ongoing record availability and retention responsibilities, and to section XXII of the Order for other continuing obligations.
