ORDER ON SECOND JOINT MOTION FOR EXTENSION OF TIME TO FILE PREHEARING EXCHANGES

Complainant filed a Second Joint Motion for Extension of Time to File Prehearing Exchanges ("Motion") on September 15, 2011. In that Motion, Complainant states that the parties have reached a settlement in principle that includes, among other things, a supplemental environmental project. Complainant asks for an additional forty-five (45) days to finalize the consent agreement and final order ("CAFO") and sixty (60) days to file its prehearing exchange. Complainant states that the Respondent concurs in the request. This is the second request for extension of the prehearing exchange schedule.

For good cause shown, I hereby GRANT Complainant's request. The CAFO is due November 14, 2011 and if not filed, then Complainant's Initial Prehearing Exchange is due November 29, 2011.
