ORDER

Complainant, by lawful delegation, the Director of the Land and Chemicals Division, U.S. Environmental Protection Agency Region 5, has moved for entry of a Default Order against Respondent JLM Chemicals, Inc. for its failure to file an Answer in this matter.

In support of its motion, Complainant has submitted numerous documents as attachments and exhibits which have been redacted on the basis that they contain Confidential Business Information (CBI). The Consolidated Rules of Practice (40 C.F.R. Part 40) require that, when a person wishes to assert a business confidentiality claim for documents filed in a proceeding under these rules, two versions be filed with the Regional Hearing Clerk: (1) one version containing the information claimed to be confidential with a cover page asserting a CBI claim; and (2) a second version with the information claimed confidential redacted. See 40 C.F.R. 22.5(d)(2). Both versions of the document shall be served on the President Officer. See 40 C.F.R.5(d)(3). It appears that unredacted documents were not filed with the Regional Hearing Clerk nor served on the Presiding Officer in this proceeding.

Accordingly, Complainant is hereby ORDERED on or before February 25, 2011, to file with the Regional Hearing Clerk and serve upon the Presiding Officer <u>unredacted</u> versions of all documents for which it asserts a business confidentiality claim pursuant to 40 C.F.R. § 22.5(d)(2) and (3).
