ORDER ON SECOND JOINT MOTION TO EXTEND THE PERIOD FOR THE PREHEARING EXCHANGES

On January 19, 2011, the undersigned issued a Prehearing Order ("Order") setting forth certain requirements and submission deadlines for the parties in this matter. On February 8, 2011, Complainant filed a Joint Motion to Amend the Prehearing Order seeking a six-week extension, which was granted by Order issued February 10, 2011. On March 28, 2011, the parties filed a Second Joint Motion to Extend the Period for the Prehearing Exchanges ("Joint Motion") seeking additional time to execute a finalized agreement. In support of this Joint Motion, the parties state that the Respondent has signed the Consent Agreement and Final Order ("CAFO"), but EPA requires a short period to review and execute it.

The parties propose that the new deadlines for the Prehearing Exchange be as follows:

- Complainant's Initial PHE - April 13, 2011
Respondent's Initial PHE - May 11, 2011
Complainant's Rebuttal PHE - May 25, 2011

For good cause shown, the Joint Motion it is hereby GRANTED. The January 19, 2011, Prehearing Order is amended as set forth above.
