

ORDER TO STAY THE DEFAULT PROCEEDINGS

By *Motion for Entry of Default on Liability* (“Motion”) dated May 20, 2008, the Complainant seeks entry of a default order on liability against the Respondent, Pueblo International (La Reine) Public Water System by its manager, Steve Bockino. By *Order to Supplement the Record*, dated October 1, 2008, the Undersigned directed the Complainant to provide additional information.

On October 21, 2008, Mr. Michael Sheesley, the attorney representing World Fresh Markets, the entity that acquired the assets of the named Respondent in this matter, contacted the Undersigned to advise that he did not receive notice of the default proceeding until his client was served with the *Order to Supplement the Record*.

Subsequently, Mr. Sheesley and Attorney for Complainant, Melva Hayden, discussed various issues related to this matter, including Mr. Sheesley's belief the named Respondent may not be the correct Respondent in this matter.

The parties agreed to a second teleconference to sort out the numerous issues in this matter.

After sending Mr. Sheesley a copy of the Motion and accompanying documentation, Ms. Hayden served a *Status Report* dated October 30, 2008, which set forth much of the information set forth herein and included additional documentation in compliance with the Undersigned's *Motion to Supplement the Record*.

Based upon the record in this matter, and in light of the considerations set forth herein, the Undersigned issues the following **ORDER**.

IT IS ORDERED:

The default proceedings in this matter are hereby stayed through December 1, 2008, during which time the Undersigned directs the parties to continue discussions in an attempt to resolve this matter. The parties are hereby directed to file a joint Status Report by December 1, 2008, upon receipt of which the Undersigned will evaluate the status of these proceedings and issue further orders as necessary.
