
**COMPLAINANT NOTICE OF WITHDRAWAL OF COMPLAINT**

1. On September 26, 2012, Complainant filed the Complaint with the Regional Hearing Clerk pursuant to 40 C.F.R. §22.5.
2. On November 6, 2012, Complainant served Three C's Management and Development Corporation, Cleveland, Ohio, (Respondent), with the Complaint pursuant to 40 C.F.R. §22.14(d).
3. Specifically, Complainant served Charles Carter of the office of Respondent.
4. However, Respondent, failed to file an Answer for the Complaint as required by 40 C.F.R. §22.15(a).
5. In September of 2013, Respondent closed for business.
6. In December of 2013, Respondent filed for bankruptcy.
