MODIFICATION OF EFFECTIVE DATE OF UNILATERAL ADMINISTRATIVE ORDER FOR REMEDIAL DESIGN, REMEDIAL ACTION, AND OPERATION AND **MAINTENANCE**

Pursuant to Paragraph 183 of the Unilateral Administrative Order for Remedial Design, Remedial Action, and Operation and Maintenance ("Order"), issued by EPA on April 18, 2012 (CERCLA 01-2012-0045), and consistent with the delegations specified in Paragraph 1 of the Order, Paragraph 192 in Section XXXIV (Effective Date and Computation of Time) of the Order is hereby modified to change the effective date as specified below. Specifically, Paragraph 192 of the Order is stricken in its entirety and replaced with the following:

192. This Order shall be effective on July 17, 2012. All times for performance of obligations under this Order shall be calculated from that effective date, unless the Order (including the SOW) specifies otherwise.

This modification is hereby incorporated into the Order and enforceable under it. All other provisions of the Order are unchanged.
