

REPORT RECOMMENDING CONTINUATION
OF ALTERNATIVE DISPUTE RESOLUTION PROCESS


The Chief Administrative Law Judge's Order of June 3, 2008 provides that this alternative dispute resolution (ADR) process terminates August 4, 2008. The recommendation of this Report is that the ADR process be continued for another month, to September 4, 2008.

This continuation of the ADR process is recommended because the parties' negotiations have developed a settlement in principle but additional time is needed for the preparation and filing of the Consent Agreement and Final Order ("CAFO"). In a conference call on July 29, 2008, the parties indicated their agreement on continuing the ADR process for another month.¹

The parties are commended for their success in negotiating their agreement.


