## ORDER STAYING PROCEEDINGS

This proceeding arises under the authority of Section 14(a)(1) of the Federal Insecticide, Fungicide and Rodenticide Act ("FIFRA"), 7 U.S.C. § 136I(a)(1). On July 22, 2010, this Tribunal issued an Order Rescheduling Hearing, moving the hearing in this matter to the week of November 2, 2010, and requiring the parties to submit joint stipulations on or before September 30, 2010.

On September 20, 2010, Complainant submitted a Motion for Stay and Vacatur of the July 22, 2010, Order ("Motion") seeking a two-week extension of time to submit the joint stipulations. In support of its Motion, Complainant states that Respondent has signed the Consent Agreement and Final Order ("CAFO"), but requests another two weeks to obtain the Regional Administrator's approval. For good cause shown, the Motion is **GRANTED**.

The parties have until October 14, 2010, to file the CAFO. If no CAFO is filed by that date, the joint stipulations shall be due no later than October 15, 2010. The hearing shall remain as scheduled until proof of Respondent's signature on the CAFO has been provided to this Tribunal. The filing of a CAFO will eliminate all deadlines pending in this matter.
