ORDER GRANTING MOTION FOR EXTENSION OF TIME

Per Order dated May 5, 2011, the undersigned consolidated the above matters and set deadlines for the filing of Complainant's Second Initial Prehearing Exchange by May 27, 2011, and Respondent's Prehearing Exchange by June 17, 2011, among others. Complainant filed its Second Initial Prehearing Exchange on May 25, 2011.

On June 10, 2011, Respondent filed a Motion for Extension of Time requesting a 30-day extension of time to file its Prehearing Exchange. Respondent states in the Motion that the parties have agreed in principle to the terms of a consent decree to resolve this matter as consolidated, and that they intend to codify the agreement "without delay." Respondent further states that Complainant does not oppose the Motion.

The Rules of Practice governing this proceeding, 40 C.F.R. Part 22, provide at Rule 22.7 that "the Presiding Officer may grant an extension of time for filing any document: upon timely motion of a party to the proceeding, for good cause shown, and after consideration of prejudice to other parties; or upon its own initiative." For good cause shown, Respondent's unopposed Motion for Extension of Time is hereby GRANTED.

Respondent shall file either a fully-executed Consent Agreement and Final Order, or its Prehearing Exchange, by July 18, 2011.

If no Consent Agreement and Final Order has been filed beforehand, Complainant shall file its Rebuttal Prehearing Exchange by August 1, 2011.


