Dear Mayor Fabian:

Enclosed is an Administrative Order (Order) issued by the United States Environmental Protection Agency under the authority of section 1414(g) of the Safe Drinking Water Act, 42 U.S.C. § 300g-3(g). Among other things, the Order alleges that the Town of Wheatland (Town), as owner and/or operator of the Wheatland Public Water System (System), has violated the National Primary Drinking Water Regulations at 40 C.F.R. part 141 (Drinking Water Regulations).

The Order is effective upon the date received. Please review the Order and within 10 days provide the EPA with any pertinent information you believe the EPA may not have (e.g., any monitoring that may have been done but not submitted, any public notices issued but not provided to the EPA, any updates to the numbers of connections and/or individuals served, etc.).

If the Town complies with the Order, the EPA may close the Order without further action. Failure to comply with the Order may lead to substantial civil penalties and/or a federal court injunction ordering compliance.

The Small Business Regulatory Enforcement and Fairness Act (SBREFA) may apply to this situation. Enclosed is a small business information sheet, outlining compliance assistance resources available to small businesses and small governments, in case these are relevant. SBREFA does not eliminate the responsibility to comply with the Order or the Drinking Water Regulations.

The Order requires the Town to notify the public of having violated the Drinking Water Regulations. Enclosed please find a public notice template explaining the public notice requirements in more detail.

Please be aware that you are required to submit to the EPA a plan and schedule for bringing the System into compliance with the Drinking Water Regulations. The EPA's approval of the plan and schedule does not substitute for any other approval that may be required by any other governmental agency for

modifying the System. The EPA encourages the Town to contact any such governmental agency or agencies regarding any applicable approval requirements.

Dear Commissioners:

The Safe Drinking Water Act requires that the U.S. Environmental Protection Agency notify locally elected officials of certain enforcement actions taken in their area.

An Administrative Order (Order) is being issued to the Town of Wheatland, which owns the Wheatland Public Water System, located in Platte County, Wyoming, directing it to comply with the National Primary Drinking Water Regulations. The violations alleged in the Order include exceeding the uranium maximum contaminant level (MCL), failing to notify the public of certain violations within 30 days, and failing to report certain violations to the EPA.

This Order is issued under the authority vested in the Administrator of the United States 1. Environmental Protection Agency (EPA) by section 1414(g) of the Safe Drinking Water Act (Act), 42 U.S.C. § 300g-3(g), as properly delegated to the undersigned officials.

2. The Town of Wheatland (Respondent) is a Wyoming municipality that owns and/or operates the Town of Wheatland Public Water System (System), which provides piped water to the public in Platte County, Wyoming, for human consumption.

The System is supplied by a ground water source accessed by eight wells. The water is treated 3. with gaseous chlorine for disinfection.

The System has approximately 1150 service connections used by year-round residents and/or 4. regularly serves an average of approximately 3680 year-round residents. Therefore, the System is a "public water system" and a "community water system" as defined in 40 C.F.R. § 141.2 and section 1401 of the Act, 42 U.S.C. § 300f.

Respondent is subject to the Act and the National Primary Drinking Water Regulations 5. (Drinking Water Regulations) at 40 C.F.R. part 141. The Drinking Water Regulations are "applicable requirements" as defined in section 1414(i) of the Act, 42 U.S.C. § 300g-3(i).

VIOLATIONS

6. The maximum contaminant level (MCL) for uranium is 30 micrograms per liter, $(\mu g/L)$, as established by 40 C.F.R. § 141.66(e). If the running annual average determined after four consecutive quarterly samples at any sample point exceeds the MCL, then the system is out of compliance with the MCL. 40 C.F.R. § 141.26(c)(3)(i). Uranium monitoring results from the System's water at sample point SP03 from (1) the 4th quarter of 2014 through the 3rd quarter of 2015, and from (2) the 1st quarter of 2015 through the 4th guarter of 2015, computed on a running annual average basis according to § 141.26(c)(3)(i), exceeded the MCL for uranium. Respondent, therefore, violated the uranium MCL. 40 C.F.R. § 141.66(e).

7. Respondent is required to notify the public of certain violations of the Drinking Water Regulations. 40 C.F.R. §§ 141.201-141.211. Exceeding the uranium MCL is a Tier 2 violation, and public notice must be provided to the public as soon as practical, but no later than 30 days after the System learns of the violation. 40 C.F.R. § 141.203(b). Respondent failed to notify the public of the violations cited in paragraph 6, above, within 30 days and, therefore, violated this requirement. The public notice should have been issued by October 31, 2015, and January 31, 2016, for each violation Town of Wheatland, Respondent Town of Wheatland Public Water System Page 2 of 4

listed in paragraph 6, above. Respondent belatedly notified the public of the first uranium MCL violation, from the 4th quarter of 2014 through the 3rd quarter of 2015, on March 1, 2016.

8. Respondent is required to report any failure to comply with any Drinking Water Regulation to the EPA within 48 hours (except where the Drinking Water Regulations specify a different time period). 40 C.F.R. § 141.31(b). Respondent failed to report the violations cited in paragraphs 6 and 7, above, to the EPA and, therefore, violated this requirement.

<u>ORDER</u>

Based on the above violations, Respondent is ordered to perform the following actions upon Respondent's receipt of this Order (unless a different deadline is specified below):

9. Within 60 days of receipt of this Order, Respondent shall provide the EPA with a plan and schedule for the System to come into compliance with the uranium MCL in 40 C.F.R. § 141.66(e). The plan shall include proposed modifications to the System, estimated costs of modifications, and a schedule for completion of the project and compliance with the uranium MCL. The proposed schedule shall include specific milestone dates and a final compliance date (to be within six months from the date of this Order or by the final compliance deadline in EPA's approval of the schedule). The schedule must be approved by the EPA before construction or modifications can begin.

10. The schedule required by paragraph 9, above, shall be incorporated into this Order as an enforceable requirement upon written approval by the EPA.

11. Within 30 days after receipt of the EPA's approval of the schedule required by paragraph 9, above, Respondent shall provide the EPA with quarterly reports on the progress made toward bringing the System into compliance with the uranium MCL. Each quarterly report is due by the 10th day of the month following the relevant quarter.

12. The System shall achieve and maintain compliance with the uranium MCL in 40 C.F.R. § 141.66(e) by the final date specified in the EPA-approved schedule. If the plan fails to achieve permanent compliance, the EPA may order further steps and/or seek penalties for noncompliance.

13. Within 30 days after receipt of this Order, Respondent shall notify the public of the violations cited in paragraph 6, above, following the instructions provided with the public notice template enclosed with this Order. The notice must be repeated every three months as long as the violation or situation persists. 40 C.F.R. § 141.203(b). Thereafter, following any future violation of the Drinking Water Regulations, Respondent shall comply with any applicable public notice provisions of 40 C.F.R. part 141, subpart Q. Within 10 days after providing public notice, Respondent shall submit a certified copy of the notice to the EPA.

14. For any future violation of the Drinking Water Regulations for which this Order does not specify a reporting period, Respondent shall report the violation to the EPA within 48 hours of the violation occurring, as required by 40 C.F.R. § 141.31(b). However, if the Drinking Water Regulations specify a different time period for reporting the particular violation, Respondent shall report the violation to the EPA within that different period.

15. This Order shall be binding on Respondent, and any person (e.g., employee, contractor, or other agent) acting in concert with Respondent.

16. If Respondent (a) leases or sells the System to another person or entity, or (b) contracts with or hires any other person or entity to operate the System, Respondent shall, no later than the date of such lease, sale, or other contract, provide a copy of this Order to the lessee, purchaser, or contractor. No later than 10 days thereafter, Respondent shall notify the EPA in writing of the lease, sale, or other contract, with such notification to include the name and contact information of the person who has leased, bought, or contracted to operate the System. Respondent shall remain obligated to comply with this Order even if Respondent leases the System to another person or entity or hires another person or entity to operate the System.

17. Respondent shall send all reporting and notifications required by this Order in writing to:

GENERAL PROVISIONS

18. This Order shall not constitute a waiver, suspension, or modification of any requirement of the Act or the Drinking Water Regulations. Issuance of this Order is not an election by the EPA to forgo any civil or criminal action.

19. Violation of any part of this Order or the Drinking Water Regulations may subject Respondent to a civil penalty of up to \$37,500 (as adjusted for inflation) per day of violation. 42 U.S.C. § 300g-3; 40 C.F.R. part 19.

20. Respondent may seek federal judicial review of this Order pursuant to section 1448(a) of the Safe Drinking Water Act, 42 U.S.C. § 300j-7(a).

Commenting on Federal Enforcement Actions and Compliance Activities

The Small Business Regulatory Enforcement Fairness Act (SBREFA) established a SBREFA Ombudsman and 10 Regional Fairness Boards to receive comments from small businesses about federal agency enforcement actions. If you believe that you fall within the Small Business Administration's definition of a small business (based on your North American Industry Classification System designation, number of employees or annual receipts, as defined at 13 C.F.R. 121.201; in most cases, this means a business with 500 or fewer employees), and wish to comment on federal enforcement and compliance activities, call the SBREFA Ombudsman's toll-free number at 1-888-REG-FAIR (1-888-734-3247).

Every small business that is the subject of an enforcement or compliance action is entitled to comment on the Agency's actions without fear of retaliation. EPA employees are prohibited from using enforcement or any other means of retaliation against any member of the regulated community in response to comments made under SBREFA.

Your Duty to Comply

If you receive compliance assistance or submit a comment to the SBREFA Ombudsman or Regional Fairness Boards, you still have the duty to comply with the law, including providing timely responses to EPA information requests, administrative or civil complaints, other enforcement actions or communications. The assistance information and comment processes do not give you any new rights or defenses in any enforcement action. These processes also do not affect EPA's obligation to protect public health or the environment under any of the environmental statutes it enforces, including the right to take emergency remedial or emergency response actions when appropriate. Those decisions will be based on the facts in each situation. The SBREFA Ombudsman and Fairness Boards do not participate in resolving EPA's enforcement actions. Also, remember that to preserve your rights, you need to comply with all rules governing the enforcement process.

EPA is disseminating this information to you without making a determination that your business or organization is a small business as defined by Section 222 of the Small Business Regulatory Enforcement Fairness Act or related provisions.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Town of Wheatland Public Water System Has Levels of Uranium Above Drinking Water Standards

Our water system recently violated a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what happened, what you should do, and what we are doing to correct this situation.

We routinely monitor for the presence of drinking water contaminants. Following receipt of the lab report for the sample collected on October 14, 2015, from the N. Settling Basin sample site, the computed running annual average (RAA) showed that our system exceeds the standard, or maximum contaminant level (MCL), for uranium. The standard for uranium is 30 μ g/L. The average level of uranium at the N. Settling Basin sample site, from the 1st quarter 2015 through the 4th quarter 2015, was 31 μ g/L.

What should I do?

- There is nothing you need to do. You do not need to boil your water or take other corrective actions. However, if you have specific health concerns, consult your doctor.
- If you have a severely compromised immune system, have an infant, are pregnant, or are elderly, you may be at increased risk and should seek advice from your health care providers about drinking this water.

What does this mean?

This is not an emergency. If it had been, you would have been notified within 24 hours. However, some people who drink water containing uranium in excess of the MCL over many years may have an increased risk of getting cancer or kidney toxicity.

You can do this by posting this notice in a public place or distributing copies by hand or mail.

Template on Reverse

Chemical or radiological maximum contaminant level (MCL) violations require Tier 2 notification. You must provide public notice to persons served as soon as practical but within 30 days after you learn of the violation [40 CFR 141.203(b)]. You must issue a repeat notice every three months for as long as the violation persists. Your primacy agency may have more stringent requirements for MCL violations (e.g., it may require you to provide water from an alternate source). Check with your agency to make sure you meet all requirements. Use Template 2-4 for fluoride MCL violations.

Community systems must use one of the following methods [40 CFR 141.203(c)]:

- Hand or direct delivery
- · Mail, as a separate notice or included with the bill

Noncommunity systems must use one of the following methods [40 CFR 141.203(c)]:

- Posting in conspicuous locations
- Hand delivery
- Mail

In addition, both community and noncommunity systems must use another method reasonably calculated to reach others if they would not be reached by the first method [40 CFR 141.203(c)]. Such methods could include newspapers, e-mail, or delivery to community organizations. If you mail, post, or hand deliver, print your notice on your system's letterhead, if available.

The notice on the reverse is appropriate for mailing, posting, or hand delivery. If you modify this notice, you must still include all required PN elements from 40 CFR 141.205(a) and leave the mandatory language unchanged (see below).

Mandatory Language

Mandatory language on health effects (from Appendix B to Subpart Q) must be included as written (with blanks filled in). This notice includes a placeholder for a specific contaminant's health effects language.

You must also include standard language to encourage the distribution of the public notice to all persons served, where applicable [40 CFR 141.205(d)]. This language is also presented in this notice in italics and with an asterisk on either end.

Corrective Action

In your notice, describe corrective actions you are taking. Do not use overly technical terminology when describing treatment methods. Listed below are some steps commonly taken by water systems with chemical or radiological violations. Depending on the corrective action you are taking, you can use one or more of the following statements, if appropriate, or develop your own text:

- We are working with [local/state agency] to evaluate the water supply and are researching
 options to correct the problem. These options may include treating the water to remove
 [contaminant] or connecting to [system]'s water supply.
- We have stopped using the contaminated well. We have increased pumping from other wells, and we are investigating drilling a new well.
- We have increased the frequency that we will test the water for [contaminant].
- We have since taken samples at this location and had them tested. These samples show that we meet the standards.

Repeat Notices

If this is an ongoing violation and/or you fluctuate above and below the MCL, you should give the history behind the violation, including the source of contamination, if known. List the date of the initial detection, as well as how levels have changed over time. If levels are changing as a result of treatment, you can indicate this.

After Issuing the Notice

Make sure to send your primacy agency a copy of each type of notice and a certification that you have met all public notification requirements within ten days after issuing the notice [40 CFR 141.31(d)].
