This letter follows up on two Prospective Purchaser Agreements, Docket Nos. CERCLA-RCRA-03-2021-0050PP and CERCLA-RCRA- 03-2021-0051PP, (the PPAs) pertaining to the above-captioned Facility. The PPAs were executed on December 18, 2020 by the U.S. Environmental Protection Agency (EPA), the U.S. Department of Justice (DOJ), and NP Falls Township Industrial, LLC (NP Falls Township Industrial), and EPA, DOJ, and NP Falls Township Industrial 2, LLC (NP Falls Township Industrial 2).

In keeping with EPA's "Guidance on Agreements with Prospective Purchasers of Contaminated Property," dated May 24, 1995, EPA provided the public with the opportunity to comment on the PPAs. From December 30, 2020 to January 29, 2021, EPA solicited public comments on the PPAs via a notice on its website and a notice in the Bucks County *Courier Times*. From March 26, 2021 to April 26, 2021, EPA also solicited public comments on the PPAs via a *Federal Register* notice. EPA did not receive any comments on the PPAs during either comment period.

Accordingly, pursuant to Section XXXI. (Effective Date) of the PPAs, EPA is hereby notifying NP Falls Township Industrial and NP Falls Township Industrial 2 that the PPAs are fully executed and effective as of the date of this letter. The final, file-stamped PPAs are attached.
