Magnate is in receipt of your January 28th "post hearing" brief. Whereas, Mr. Goldman wants to dismiss Magnate's assertions (made) for multiple statutory reasons, Magnate will concede, that for the purpose of this hearing, Magnate will rely on its original arguments as to the perfecting of the lien.
