The U.S. Environmental Protection Agency, Region 5, is providing notice of its intent to issue a Consent Agreement and Final Order (CAFO) that assesses a civil penalty of \$176,804.63 to Team Disposal Systems, LLC (Respondent) under the authority of Section 1423(c)(2) of the Safe Drinking Water Act (SDWA), 42 U.S.C. §300h-2(c).

The CAFO will resolve Respondent's liability for the civil penalty for EPA's allegations contained therein (as well as requiring a return to compliance), in that Respondent failed to comply with the SDWA, 42 U.S.C. §300h-2, requirements of its Underground Injection Control (UIC) Permit No. MI-055-2D-C034, EPA No. MI-055-2D-C013, and EPA No. MI-101-2D-C013 (Permit(s)), and the UIC regulations at Title 40 of the Code of Federal Regulations Part 144 at its Class II injection well facilities in Grand Traverse and Manistee counties, Michigan (Well(s)). Specifically, EPA alleges in the CAFO that Respondent failed to submit timely monthly monitoring reports, failed to submit monthly operating reports, failed to monitor annulus liquid loss, failed to report annulus liquid loss, failed to submit quarterly operating reports, injected unauthorized fluids, failed to submit annual reports, and failed to submit information.

In addition to payment of the civil penalty, the CAFO requires that Respondent implement compliance measures at its Well(s). Pursuant to the compliance plan, Respondent must cease injection of unauthorized fluids, measure and report the annulus liquid loss, provide documentation that all of the wells have calibrated gauges that are able to read negative pressures, submit monthly, quarterly and annual reports required under the Permits, and create and implement a standard operating procedure for the monitoring, recording, and reporting practices required by the Permits.

OPPORTUNITY FOR COMMENT: EPA is providing public notice of the proposed settlement pursuant to Section 1423(c)(3) of SDWA, 42 U.S.C. §300h-2(c)(3) and 40 C.F.R. 22.45(b).

Any person who wishes to comment on this proposed CAFO or participate in any proceedings may do so pursuant to 42 U.S.C. § 300h-2(c)(3) and by following the procedures described in 40 C.F.R. § 22.45, particularly Subpart (c) *comment by a person who is not a party*. “Any person wishing to participate in any hearing held must notify the Regional Hearing Clerk via email or in other writing within the public notice period and provide his name, complete mailing address, and state that he wishes to participate in the proceeding.” See 40 C.F.R. § 22.45(c)(1). Should EPA decide to propose issuance of a Final Order after considering any comments received, EPA will send a copy of the Consent Agreement and proposed Final Order to any persons who submitted written comments during the public comment period. Commenters may refer to: (1) 40 C.F.R. § 22.45(c)(4) for information on petitioning the Regional Administrator to set aside the Consent Agreement and proposed Final Order on the basis that material evidence was not considered; and/or (2) 42 U.S.C. § 300h-2(c)(6) for information on filing an appeal with the appropriate United States District Court.
